COMMENTS RECEIVED AND FAA RESPONSES ON THE FINAL EIS

The comments received by the FAA on the Final Environmental Impact Statement (Final EIS) document are presented in this appendix. The 30-day comment period began on June 27, 2008 with the publication of the Federal Register Notice of Availability of the *Final Environmental Impact Statement for the Development and Expansion of Runway 9R/27L and Other Associated Airport Projects at Fort Lauderdale-Hollywood International Airport, Broward County, Florida*. The 30-day comment period ended on July 28, 2008.

The FAA received additional comments from the City of Dania on October 6, 2008 and October 10, 2008. These comments were reviewed by the FAA to determine if any significant, substantial, or new issues were raised regarding the analysis or information contained in the Final EIS that had not previously been submitted, considered, and responded to in this ROD. The FAA summarized these additional comments and has provided responses in this appendix.
