
#### II. INTAKE ANALYSIS

#### 1. INTAKE TRENDS AND BACKGROUND

Dog intake from FY2016 to FY2018 has declined by approximately 17%, while cat intake has increased by 10%. In addition, intake for the first three quarters in FY2019 are unchanged when compared to the first three quarters in FY2018. During this time period, dog intake has increased by 12% and cat intake has increased by 10%.

Cats make up approximately 62% of the intake population, while dogs make up approximately 38%. Intake from Stray pickup accounts for 74% of all intake and intake from owners relinquishing their animals account for 15% for combined 89% of total intake.



#### 2. STRAY INTAKE


The Stray intake analysis was conducted to answer the following questions:

• Where are the areas in the County with the highest stray animal intake for dogs and cats?

The categorization of Well Above Average, Above Average, Average, and Below average were determined based on computed standard deviations from the average.


The top 10 municipalities with the highest intakes for dog are Hollywood, Fort Lauderdale, Pompano Beach, Miramar, Davie, Lauderhill, Pembroke Pines, Dania Beach, Plantation, and Sunrise. The percentage of dog intake ranges between 37% to 50% for medium size dogs and 26% to 35% for large size dogs.

The top 10 municipalities with the highest intake of cats are Hollywood, Fort Lauderdale, Miramar, Davie, Pembroke Pines, Pompano Beach, Dania Beach, Sunrise, Plantation and Lauderhill. The percentage of kitten intake within these municipalities ranges from 68% to 76%.


#### GIS Maps – Census Tracts 2010 categorized as "Well Above Average" for Dog Intake


































Bar Chart - Census Tracts 2010 categorized as "Well Above Average" for Dog Intake




































GIS Map – Overview of Stray Cat intake by U.S. Census Tracts 2010




Bar Chart – Census Tracts categorized as Well Above Average for Cat Intake

The top 5 zip codes with the highest intake from owners relinquishing their animals are 33311, 33312, 33023, 33020 and 33024.





Chart – Top 15 Zip codes with high intake from owners relinquishing their animals.

#### 4. CRUELTY/CONFISCATION INTAKE

#### 4.1 Identification areas with the highest intake due to pet cruelty and confiscation


The top 5 municipalities with the highest intake of pet cruelty and confiscation are Fort Lauderdale, Pompano Beach, Hollywood, Lauderhill, and Lighthouse Point. Dogs account for approximately 77% to 90% of the intake within the top 5 municipalities, except for Lighthouse Point. Cats account for 89% of animals confiscated in Lighthouse Point.

Bar Chart – Cruelty/Confiscation Intake by Zip Code FY2016 – FY2019 Quarters 1 - 3




#### III. OUTCOME ANALYSIS

#### 1. OUTCOME TREND AND BACKGROUND

Dispositions consist of Adoption, Return to Owner, Transferred to Another Agency/Rescue, Return to Field, Died in Care, Lost in Care, Shelter Euthanasia, and Owner Intended Euthanasia.

Adoptions consist of the greatest proportion of total outcome at 44%, followed by Return to Owner at 19%, Transferred out at 16%, Shelter Euthanasia at 15%.






Total adoptions in FY2016 were at 4,261 and increased in FY2017 to 4,354. In FY2018, adoptions decreased to 3,981. Total animals euthanized were at 2,082 in FY2016, and decreased to 1,841 in FY2017, and to 1784 for FY2018. Return-to-Field increased to 1183 in FY2017 from 797 in FY2016. In 2018, Return-to-Field increased to 1,149 from FY2017.

#### 1.1 Cat Outcomes by Weight Group

In FY2016 to FY2019 3<sup>rd</sup> Quarter, large cats accounted for 67% of cat euthanasia, medium size cats accounted for 22% of all euthanasia, and kittens accounted for 11%.



#### 1.2 Dogs Outcomes by Size


#### 1.2.1 Large to Very Large Dogs

Within the large and very large-sized dog outcome population, adoption and return to owner accounts for roughly 60% to 61% of all outcomes within their respective size categories. Euthanasia, including shelter and owner requested euthanasia, accounted for approximately 30% to 31% for large and very large-sized dogs. However, outcomes based on the owner's request for euthanasia are higher within the very large-sized outcome population by 11.4%.

Very large dogs have the highest rate of Return-to-Owner compared to any other size category.

#### 1.2.2 Small to Medium Size Dogs

The percentage of dogs adopted within the small-sized dog outcome population are lower than adoptions from the medium-sized dog outcome population. Adoptions account for 44% of all small-sized dog outcomes and 49% of all medium-sized dog outcomes.




Pie Chart – Dog Outcomes by Proportion


#### 1.2.3 Adoption and Rescue

Small dogs account for 35% of all dogs adopted and 60% of all dogs rescued. Medium dogs account for 50% of all dogs adopted and 28% of all dogs rescued. Large to very large dogs account for 15% of all dogs adopted and 12% of all dogs rescued.

#### 2. LIVE OUTCOMES AND EUTHANASIA

#### 2.1 Adoption, Rescue, Return-to-Owner, and Return to Field Trends

Total animals adopted have decreased 7% in FY2018 over FY2017. Adoptions rates are up 18% for FY2019 QTD (4,564) over FY2018 QTD (3,852). Total dog adoptions are up 13% in FY2019 QTD (1,640) over FY2018 QTD (1,451). Total cat adoptions are up 21% in FY2019 QTD over FY2018 QTD.

Total animals rescued have decreased 26% in FY2018 (1,267) over FY2017 (1,713) and are down 3% for FY2019 QTD (996) over FY2018 QTD (1,030). Total dogs rescued are down are 17% in FY2019 QTD (487) over FY2018 QTD (581). Total cats rescued are up 13% in FY2019 QTD (509) over FY2018 QTD (449).

Total animals returned to the field are down 2% in FY2018 over FY2017 and are up 33% for FY2019 QTD (1,680) over FY2018 QTD (1,260).






#### 2.2 Live Release

The live release has increased from 74% in FY2017 to 85% for FY2019 as of June 30, 2019. Live Release Rate for cats has improved from 71% in FY2016 to 84% for FY2019 QTD. Dog live release rate has improved from 80% in FY2016 to 89% for FY2019 QTD.


Line Chart – Live Release vs Euthanasia and Other Rates FY2016 – FY2019 Quarters 1 - 3 for Dogs and Cats
