



## GALT MILE and LAUDERDALE-BY-THE-SEA

### Alternative Transportation Options

The City of Fort Lauderdale City Commission held a public hearing on November 21, 2017 and approved the temporary suspension of the Sun Trolley Galt Link route to be effective on December 1, 2017 through May 30, 2019. During the 18-month suspension period, City staff will work with the Florida Department of Transportation (FDOT), the Transportation Management Association (TMA), Broward County Transit (BCT), and our neighbors to study system adjustments to reach key destinations and increase efficiencies to better meet passenger needs. Technical assistance is being provided by FDOT to complete a system-wide efficiency study that will include the Galt Link. We need the input of our neighbors to help plan the future route. Recommendations will be presented to the City Commission for approval at a later date. In the meantime, the last day of Galt Link service before the temporary suspension is Wednesday, November 30, 2017. - \$3.50 per ride
- Door-to-door servicing all destinations throughout the greater Broward County area
- Operates the same hours as BCT fixed route service (generally early morning until late at night)
- Must meet qualification criteria, complete an application, and participate in an evaluation procedure to determine eligibility of using this service

#### **Broward County Transit (BCT) Fixed Route Service**

- \$2.00 per ride. Senior citizens 65 years and older are eligible for a reduced fare of \$1.00 (must present valid identification)
- BCT Route 11, serving Pompano Beach and Las Olas
- BCT Route 72, serving Oakland Park, Lauderhill, and Sunrise
- BCT Route 55, serving North Lauderdale and Tamarac
- Operates generally early morning until late at night, 7 days per week / varies per route and per day
