SHELDON MCCARTNEY, Chair (Southwest Ranches) Sheldon McCartney is Chairman of Board of the Project Stable Foundation and serves on the advisory board of the Old Davie School Historical Museum Board. His past achievements include President of the award winning McCartney Construction Company, responsible for noted restoration projects throughout Miami/Dade, Broward, and Palm Beach Counties. Projects include Miami City Hall, Edison Middle School, Old Miami Beach City Hall,

Colony Theatre in Miami/Dade County, Peele Dixie water plant, New River Court, Old Dillard School, Old Davie School and Viele House in Broward County, and the Flagler Museum and North Fire Station in Palm Beach. Well versed in construction and now retired from his firm, he stays active in the construction industry as a board member of the Constructions Specifications Institute and is a consultant to non-profit organizations. ### DEREK T. DAVIS, Vice Chair (Miramar)

Derek Davis is the former Curator of the Old Dillard Museum in Fort Lauderdale, developing cultural and educational programs at a historic schoolhouse listed on the National Register of Historic sites, built as the first public school building for blacks in Broward County. His work includes organizing exhibitions, administering musical concerts, managing collaborations with cultural organizations, facilitating

policies and procedures for non-profit fundraising organizations, conducting tours, overseeing website development and managing the museum staff. As a high school student during the period of racial protests in the late 1960s, he wrote a play, "Black Search for the Future" that was lauded, videotaped by Channel 10 and viewed all over South Florida. He's worked for The Miami Herald, the Black Archives History and Research Center, the African American Research Library, and Broward County Schools. He received his Bachelor's Degree in Mass Communications from Florida Atlantic University. Appointed by Commissioner Dale V. C. Holness, Derek Davis serves as a Member of the Board and fills the professional category of Conservation or Curation.

Her debut book, a pictorial and written oral history of the first decade of Carver Ranches, stemmed from her grandparents, who were original pioneers of the area. She currently owns,

occupies, and maintains the first Broward County-designated historical site and operates a community history museum on the site. Cynthia has added "Author" to her list of sobriquets with Promises from the Palmetto Bush, the Genesis of Carver Ranches. ### JONATHAN AXLER, Member (Davie/Fort Lauderdale)

Jonathan Axler is the Parks Service Specialist for the Barnacle State Historic Park, Miami-Dade County's oldest house still in its original location. Axler has served in that position since August of 2022. Axler is responsible for a variety of park operations, including school and group tours, community programs, outreach, exhibits, collections management, and distance learning. He provides historical interpretation

for children and adult programs and helps recruit and train volunteers. A South Florida native, Axler previously served as Education and Curatorial Coordinator at the Historic Stranahan House Museum; Museum Assistant at the Plantation Historical Museum and Gallery Curator at Flamingo Gardens wildlife sanctuary, aviary and botanical garden. Axler is currently a board member of the Broward County Historic Preservation Board and a member of Gold Coast Archivists. Axler earned his Bachelor of Arts from Florida Atlantic University where he is currently seeking a Master's in History.

### ANTHONY ABBATE, Member (Fort Lauderdale)

Anthony Abbate is Professor at the School of Architecture at Florida Atlantic University and former Associate Provost for the Broward Campuses. He is also an NCARB certified architect registered in Florida and New York, with a Master of Architecture from Washington University and a Bachelor of Science in Architecture from the Catholic University of America. Abbate received the William G. McMinn Award for Outstanding Architectural Education from the Florida

Association of the American Institute of Architects in 2014, the Arango Design Award in 2000, Washington University's Distinguished Alumni Award in 1995, and 25 awards from the American Institute of Architects for design excellence as well as the President's Award for Distinguished Service.

He is a past chair of the Broward County Cultural Council and former chair of the County's Public Art and Design Committee. He served on the City of Fort Lauderdale's Board of Adjustment, chaired the City's first Sustainability/ Green Committee, chaired the Sustainability Advisory Board, and chaired the Beach Redevelopment Advisory Board (BRAB). He is Past President of the Rotary Club of Fort Lauderdale and the Rotary Fort Lauderdale 1090 Foundation.

With a long record of community service and leadership, he currently serves on the board of directors of the Greater Fort Lauderdale Chamber of Commerce and Hispanic Unity of Florida (HUF). He is a member of Leadership Florida; and is also a regular contributor to the Sentinel's South Florida 100 opinion page. Appointed in 2019 by then Commissioner Tim Ryan, Anthony Abbate serves as a member on the Board and fills the Licensed Architect category.



More than 55 years ago, successful Fort Lauderdale builders, James S. Hunt and Joe Taravella of Coral Ridge Properties, had the vision to create a planned city from the ground up that they named Coral Springs. The first land purchase was for \$1M for 3,860



acres of green bean crops and cattle fields. To draw interest in the land that was sometimes considered "too far out", they constructed a covered bridge and recruited talk show host Johnny Carson for a land sale BBQ. The event was a huge success.

Dania Beach is Broward County's first city. The historic roots of the first city in Broward County date back to the 1880's, when much of what is now the FEC railroad line was laid through the area. In recognition of this transportation advantage, a pioneer and developer named W. C.

Valentine planned a settlement called Modello and 12 Danish families moved from Chicago to settle there in 1898-1899. Three years later, 30 Danes were recruited from Oconto, Wisconsin to colonize the settlement, and the first home was built by A.C. Frost, for whom a park is now named. When the Town was incorporated in November 1904, its 35 residents changed the name to Dania.

# MICHAEL CROWLEY



**MIKE CROWLEY** came to Florida in 1967 from New York with a large extended family. When he first arrived, he remembers seeing cow pastures and citrus fields everywhere and no development. He started a lawn company and maintained the yards of many of the Town pioneers, before working at the Central Broward Water Control District from 1989, working on flood protection. He worked his way up to District Manager and recently retired after 33 years of service.

He has served on the Water Advisory Board, the Site Plan Committee, and the Town of Davie Town Council for seven years (2003-2010) and is currently serving on the Planning & Zoning Board (since 1999). Mike worked with the Town of Davie Town Council to purchase the property adjacent to the Old Davie School for use as the main entrance, a passive park, and a wetland area and has sought to keep it maintained since. He has been on the Old Davie School Historical Museum Board since 2003 and has served as its president since 2018.

# GLORIA BATTLE



**GLORIA BATTLE** is a second-generation Floridian. She and her mother were born in Broward County, and because of segregation Branhilda Richardson Knowles, a mid-wife, delivered both of them in Deerfield Beach. When she matriculated in the Broward County School System racial segregation kept Caucasian and African Americans from studying together. Your race also determined where you lived. How ironic that she returned home after attending college and spent 20 years

as Director of the Broward County Human Rights Division where she had the responsibility of investigating housing and employment discrimination cases.

As a student of activism, having honed those skills while studying at Howard University, she has always and continues to be active in her community. She sat on the Deerfield Beach Commission and continued her activism from the dais. For years, the African American community insisted that property located on land scheduled for a housing development project was actually the first African American Cemetery. Because of her insistence and research, the site is now the home of the Historic Branhilda Richardson Knowles Memorial Park, designated by the National Register of Historic Places.

Born in Blackville, SC, Army Veteran **ROOSEVELT WALTERS** has had a 35 year career with Broward Transit.

Mr. Walters recalls the wade-ins led by then NAACP President Eula Johnson, and remembers having to take a ferry to swim at the beach - today's Von Mizell &

Eula Johnson State Park. This pivotal event brought about the desegregation of Broward County's beaches began the Civil Rights movement locally.

Since then he has held various committee appointments at the County, Broward County School Board, and City of Fort Lauderdale, and has been a mass transit advocate for transit oriented development.

The City of Fort Lauderdale is named for a Second Seminole War fortification built on the banks of the New River in 1838. That year,

Major William Lauderdale led a detachment of Tennessee Volunteers south along the east coast of Florida to capture Seminole agricultural lands and battle the elusive Indian warriors.

It was not until the Florida East Coast Railroad built tracks through the area in the mid-1890s that any organized development began. The city was incorporated in 1911, and in 1915 was designated the county seat of newly formed Broward County.

The northern edge of Hallandale Beach (along Pembroke Road) still features noticeable hammocks, points elevated above sea level in the distant past. The city is named after Luther Halland, the son of a Swedish worker for Henry Flagler's Florida East Coast Railroad.

A unique town is that it has only one road, with this road running north-south for the entire length of the Town. Just 3 miles long and 900 feet at its widest point, there are approximately 50 single-family residences, and the rest of those residing in Town live in condominiums.

Hillsboro Beach is known far and wide for the Hillsboro Lighthouse, marking the northern end of the Florida Reef and extending 138 feet skyward. Capped with 5.5 million candlepower light, it's one of the tallest and most well-lit lighthouses on the U.S. East Coast.

# CITY OF PARKLAND

In the early-1960s, Bruce Barnett Blount, from Mississippi, inherited land in the northwest corner of Broward County from his parents. He had a vision to form a city on a portion of the land he owned, even though in 1963 Parkland had about 22 citizens and a total of nine homes. The City



Charter was approved by the Florida House of Representatives on July 10, 1963.

In the late 1970s Narco Realty developed the land called Parkland Lakes Planned Unit Development (also known as Cypress Head), and built a \$75,000 City Hall ("Old" City Hall at Holmberg and Park Side Drive). Parkland became ready for the housing boom in 1982, when an upgraded Holmberg Road was extended further west, with traffic circles and traffic lights.

### POMPANO BEACH

Pompano Beach celebrated the 100th anniversary of its incorporation on July 3, 2008. It is the second oldest city in Broward County, and the fifth oldest in all of South Florida. Only Key West, West Palm Beach,



Miami and Dania Beach became municipalities earlier than Pompano (the "Beach" came later).

Other than Key West, which by the 1820s was already an important port and city, the towns of southeast Florida came into being because of the railroad. In 1896, Henry Flagler decided to extend his Florida East Coast Railway south from West Palm Beach to Miami, opening up land that heretofore had been a virtual wilderness.

Hundreds of citizens from the Southwest Ranches area, called for the right to form their own city, to avoid annexation into Pembroke Pines and to preserve its semi-rural lifestyle. As a result of this grassroots effort, the State Legislature passed a bill in the 1997 session calling for a vote of the citizens of Southwest Ranches which became the County's 30th incorporated place in March 2000.

# RICHARD & BARBARA MCCALL

The Town of Davie is honored to submit Richard and Barbara McCall for the Judge Clayton Nance Memorial Award.

Barbara is a Davie native and was educated at Davie Elementary, Fort Lauderdale High, and Florida State University, where she graduated with a bachelor's degree in Nursing. Richard came to Davie as a teenager,



attending Fort Lauderdale High and the University of Florida (taking classes in Horticulture). The two married in 1958 and just recently celebrated their 64th wedding anniversary.

Barbara's grandparents, William and Anna Griffin, were one of the first families to settle in Davie (called "Zona" at that time). Years later, Griffin Road was given their name, as a tribute to the family, by the Broward County Commission. Richard worked for the Griffin Brothers (the family landscape business) for 26 years, while Barbara ran a sewing business making wedding dresses. They had four children, all born and raised in Davie. Barbara started the McCall Nursery & Landscape with her oldest son when he was a teenager; thereafter, Richard joined the company along with the other three children.

Richard and Barbara were also very active in the community and devoted much of their time to Davie. They worked alongside her parents at the annual Orange Blossom Festivals, were school volunteers, scout leaders, church members, part of the Davie Historical Society, and have been involved with Broward County Pioneer Days for years.

Barbara also became a founding member of the Davie School Foundation and the Soroptimist International Club of Davie, a women's service

organization. These groups were formed to save the historic 1918 Davie School from demolition. She served as president and treasurer of the Foundation for many years and was instrumental in preserving the school. The Old Davie School is one of the oldest buildings in the county and was listed on the National Register of Historic Places in 1988.

Richard has always been a craftsman and decided to join Barbara in the restoration of the school and surrounding buildings. He joined the

Foundation and received a grant to develop a garden, built a 1909 pioneer house replica on the school property, refurbished the relocated 1912 Walsh home, and set up exhibits in the school.

To this day, they still do projects for the school and continue to be donors to the Foundation to keep the property viable for many generations to come.

Since retirement, they moved into Hammer Heritage Estates, a residential community in Davie their children built and live in this development amongst their grandchildren.

They are outside everyday maintaining and landscaping their yard, as well as helping neighbors with their yards and constantly doing home improvement projects.

## JUDGE CLAYTON NANCE AWARD

The Judge L. Clayton Nance Award has been presented by the Broward County Historical Commission since 1979. Among the past recipients of this award are several prominent local historians, preservation activists, newly created museums, educational organizations, and cultural sites. The Fort Lauderdale Naval Air Station, Ah Tha Thi Ki, the African-American Research Library, the Old Davie School, Broward County Urban River Trails and the Women's History Coalition are among past award winners.

Circuit Court Judge L. Clayton Nance (1924 -1979) was devoted to the study of local history. He spearheaded a drive to create a county-level commission to protect and promote local heritage and, in 1973, the Broward County Historical Commission was founded. From 1972 to 1979, he served as the official advisor to the Commission. He oversaw every facet of Commission activity, from Pioneer Days to the stocking of the research library and amassing of the Commission's map collection. Judge Nance was also the first public defender in Florida and the first public defender elevated to the Circuit Court.

# DAVIE WOMAN'S CLUB

The Town of Davie is honored to submit the Davie Woman's Club for the Stuart P. McIver Historian's Award. This nomination is especially poignant as the Davie Woman's Club is celebrating its 100th anniversary



serving the Davie community and will be celebrating its 75th anniversary at its current location. The Club has served the community since its inception; starting Davie's first library and continuing to assist many organizations over the years.

The Davie Woman's Club first meeting was held in August 1922 consisting of 18 members at the Old Davie School site. The Club opened at its current

location in 1947/48 despite a hurricane with widespread flooding impacting the area during building construction. The Davie Woman's Club is the oldest formally social service organization in Davie for women. In 2016, their clubhouse received the National Register of Historic Places designation in the area of social/entertainment/ recreation.

The Davie Woman's Club continues to be an essential part of the Davie community and culture through its service and celebration of the area's history. At the annual Orange Blossom Festival, Club members celebrate the Strawberry Shortcake Festival that has become a mainstay of the Orange Blossom Festival. The clubhouse continues to serve as a meeting place for religious events, entertainment, and other important life events.



For supporting the memory and history of the Holocaust, Rubin Stacy Initiative, local and State history and by bringing together young and old in education projects about the dangers of bigotry, hatred and intolerance.

The City of Parkland is honored to have submit Vice Mayor Ken Cutler for the Dr. Cooper C. Kirk Memorial Award. Over the years, Mr. Cutler has taken close to 50 projects, mostly in his spare time, that have unearthed histories that have been largely forgotten or ignored.

Working from his home computer and searching for books, Mr. Cutler uses some of his skills as a partner in a personal

injury and commercial litigation firm.

His various research projects have included among others - uncovering information about local land-owner John L. Homberg (Homberg Road); State Supreme Court Justice George W. Macrae; the County's last lynching victim Rubin Stacy, and incorporating stories of children lost to the Holocaust in bar or bat mitzvahs of Jewish youth today.

Long a treasurer of books and old book shops, genealogical research (including uncovering fascinating information of his own ancestors) and support for archaeological site preservation, Mr. Cutler's 50 year journey has been ceaseless and ongoing. We salute him in all that he does to ensure that Broward's history stays alive.

### DR. COOPER C. KIRK MEMORIAL AWARD

The Dr. Cooper C. Kirk Memorial Award has been presented by the Broward County Historical Commission since 1992. Most past winners of the Kirk award have published significant works on local history or been leaders in local history setting fine examples of historical research following the tradition set by Dr. Kirk who, starting in 1972, served as the first Broward County Historian.

A sought after lecturer on local history Kirk was a tireless researcher. His work on Major Lauderdale, for whom the City of Fort Lauderdale was named, was published in book form in 1982 as William Lauderdale: General Andrew Jackson's Warrior which earned him wide acclaim. The Cooper Kirk award was first given in 1992. It is traditionally presented to those involved in writing or supporting efforts regarding local history.



# PIONEER DAY: OUR BROWARD LEGACY

**THE PIONEERING SPIRIT**, lauded throughout the illustrious history of our country, can never be commended too strongly. There aren't too many places today where one can sit and hear a first-hand account of what the area was like with only a handful of settlers. Yet many in Broward County can still recall what it was like when its one-million-plus population was one-tenth that number. That's what Pioneer Day is all about. It's a celebration of those who can say "I remember when."

And, someday, some of the newer residents may be able to recount, in that same spirit, "I remember Broward County's first Pioneer Day." Shortly after the Broward County Historical Commission was formed in November 1972, Commission Member Sue Phillips suggested that the group establish an annual Countywide fair or show, honoring pioneer residents. It would permit the historical societies and other civic-oriented groups to exhibit their historical and educational materials.

The desired result, of course, was to share information about the area's history and heritage with Broward's residents. With the help of the Mental Health Association of Broward County, the First Annual *Broward County Pioneer Day* was held May 5-6, 1973, at the American Heritage School in Wilton Manors.
