The NewHart project is a 36-bed permanent housing program for disabled homeless individuals with substance use as well as co-occurring disorders such as mental illness, HIV/AIDS, who are at increased risk factors for continued substance-abuse involvement and homelessness. Housing participants may be veterans ineligible for Veteran's Supportive Housing (VASH) vouchers and/or older adults. The target population to be served as housing slots are vacated are chronic homeless individuals with co-occurring and substance use disorders who have been identified by the Broward County Continuum of Care's Coordinated Assessment & Housing Placement process as most in need of the level of assistance. The Newhart project follows a housing first program model with scattered site housing.

Challenges to housing include: substance use and relapse, mental health disorders, criminal background history, health complications and extended unemployment related to addiction. The project provides permanent supportive housing, case management and linkage and referral to a range of supportive services. Through the use of cost savings it is expected that additional clients will be served. Over a 12-month period the program will serve 36 to 38 individuals, mostly non-veteran and 4-6% may be victims of domestic violence. DV clients will be served with a trauma informed approach and provided access to victim services and therapy. Over 50% of the population will have cooccurring mental health disorders, and over 50% will have physical health problems. It is the goal of the program for 75% of the individuals served to remain in permanent housing or exit to permanent housing in the operating year. It is then estimated that 80% that exit the program will not return to homelessness within 12 months. While in the program 45% will be expected to maintain or increase income. Focus will be on increasing self-sufficiency and self-determination with vocational rehabilitation, education and training and referrals for budgeting and credit repair. The project currently uses SevicePoint for its HMIS except when serving DV clients and has a current CHO End User Agreement with the HMIS Lead. HMIS compliance with System Performance Measures is monitored at least monthly with ongoing quality assurance oversight. The performance improvement plan in place includes monitoring for timely submission of data in the Entry/Exit area at the time of new participant admissions into housing. The project subrecipient has extensive experience managing CoC & other federal grants.
