**Old Business:** Update of Extreme Weather Ad Hoc Committee by T. Campbell, Chair:

> Initial Ad Hoc Committee met, provided HIP feedback on needs and recommendations. HIP met with Broward Emergency Management (EM) and Transit to discuss needs and recommendations and recognized that there would potentially be a lot hotter weather shelter days than cold weather, there would be a high cost associated with that, Transit faces the obstacle of running during the day when activations would occur which impacts Transit's schedules; so other options are being looked at. A final determination is still needed on temperature activation, but perhaps a heat index somewhere between 105-115. The National Weather Service would trigger activation initiation. The Ad Hoc Committee will meet again to discuss Broward EM and Transit's feedback.

Update on Business Council on Homelessness by R. McGuire, HIP:

United Way and City of Fort Lauderdale stepped up and help with initiative. There has been great progress made in implementing initiative.

Good of the Order: R. Martin asked for PIT recommendations to be submitted to the CoC Board as a consent agenda of some sort to include survey stricken with changes.
