### 1. Call to Order

The meeting was called to order by Chair Arby Barroso at 1:40 PM.

### 2. Roll Call

Roll call was conducted by Staff Coordinator Cyril Saiphoo. A quorum was available with seven (7) members present.

### 3. Approval of Minutes – May 23, 2018

**MOTION:** Member Fried moved to approve the minutes of the May 23, 2018 meeting as written. Member Hyman seconded. All in favor.

### 4. Chair Report/Comments

Chair Barroso summarized the agenda items to be reviewed during the meeting.

### 5. New Business

#### a. MOTION – Recommendation to amend Article XVI. – Medical Marijuana Advisory Board, Broward County Code of Ordinances

As advised by Ms. Azcoitia, Chair Barroso moved to direct staff to draft an amendment to the ordinance, changing the requirement to meet quorum from “total appointment” members to “appointed” board members. Member Fried clarified that the quorum will be met by a majority of the appointed members instead of the total appointed positions (including vacant positions). Seconded by Member T. Davis. All in favor. Ms. Azcoitia

commented that motion to direct will be placed on the Commission agenda.

**b. MOTION – Approving Date, Time, Location, and Format for the “Medical Marijuana Educational Summit”**

**i. Discussion**

There was discussion about who will be invited and what assistance the County will be able to provide. Invitees will include elected officials, first responders, and other community leaders throughout Broward County and surrounding areas. However, the event will be open for anyone to attend. There was further discussion regarding extending the invitation to medical school students and staff. Chair Barroso responded that a second event can be planned for a broader audience. County staff offered assistance with contacting elected officials.

**ii. Public Comments**

Jeff Greene commented that he agrees with inviting only elected officials to the event and welcoming them to send a surrogate if desired. Regarding funding for a larger, subsequent event, Mr. Greene stated that he has been in contact with several medical marijuana treatment centers that would be willing to provide funding support. He also agreed to act as a non-Board point person for the upcoming educational summit and to assist with contacting elected officials.

**iii. Motions**

**MOTION:** Member Hyman moved that the Educational Summit be scheduled for a date to be announced in January 2019. Chair Barroso seconded. All in favor.

**MOTION:** Member Fried moved to create a subcommittee of no less than three (3) members to plan and organize the educational summit to be scheduled in January 2019. Chair Barroso seconded. All in favor. Members of the subcommittee are: Ed Rebholz, Nikki Fried, Seth Hyman, Arby Barroso, and Terrence Davis. The first meeting of the subcommittee was scheduled for Thursday, September 27, 2018, 9:00 a.m.-12:00 p.m. The location is to be determined. County staff will provide a call-in number for the September 27<sup>th</sup> subcommittee meeting.
