## AGENDA ITEM R-2 - EXECUTIVE DIRECTOR'S REPORT

CHAIR CASTRO: Executive Director's Report?

MS. BOY: Good morning. Good morning. I just want to briefly welcome Commissioner Gomez to the Planning Council. We had a meeting yesterday to go through the duties of the Planning Council, and I think she's going to be a great addition to the Council. Thanks to everyone for coming this morning. I'm sorry that I bothered everyone so early, but I was a little bit concerned about the quorum, so I can assure you that I won't

always be emailing you at, you know, 7:30, 7:45 the morning of a meeting.

The main thing that I have for just the Executive Director's Report is I was just going to give you all a quick update on the Browardnext effort. You know, we talked about it in October, and we just finished the -- or we were just getting ready to finish the focus area meetings. Now we've completed those focus area meetings, and we've posted all of the notes from those meetings on the browardnext.org website. And the next step of the process is we're actually preparing a survey to send out to our email list and interested parties ranking the input that we received at those focus area meetings.

And that's going to help guide the actual proposed amendments and changes to the Land Use Plan that we see probably starting next summer. So in the interim, we're working on the survey. We're going to be sending out a newsletter in the next couple of weeks, just a one-page kind of informational item. The ad hoc committee, I'm going to be polling them in the next week for a meeting date the end of January. We'll give them the -- have the results of the survey at that point, so we'll let them know how people have prioritized the different topics. And then we're going to actually have a series of meetings in February.

The City of Weston has graciously agreed to host a physical meeting as well as a webcast. It'll be in the evening, 6:00 to 8:00 p.m., so we'll announce those dates. Then we're going to have a meeting in this chambers, also 6:00 to 8:00 p.m., you know, to try and get people that this isn't their everyday job, get people, you know, hopefully more involved. We'll also have a daytime meeting from 2:00 to 4:00 for municipal planners and for people who it is their job to kind of review this stuff. So that's what's happening, and I just wanted to give you an update on that.

CHAIR CASTRO: Thank you. As a reminder, please use your social media email. Elected officials, if you can make sure not only that your cities are engaged, but if you can host regional meetings at your city location to invite other cities in, that's very, very helpful.

MS. BOY: I should have mentioned, we've also been doing outreach meetings to different organizations. We've been to the realtors' group, some of the cities. We've been invited to several cities. Smart Growth, Growing Broward, Sustainability Stewards, we've been going to all these groups, giving an overview of the process and also receiving additional input at those meetings. So I forgot to mention that. And we're available to come to homeowners' association meetings. Just get in touch with me and we'll find a time.

CHAIR CASTRO: And we know from working with this month to month that this will shape the future of the County, so what we're trying to do, not that it's going to happen, because it never does, but it would be nice at the end of the process if we didn't have anybody complain that they didn't know about it, hadn't heard about it. And I know they will. Been there, done that. But, you know, we're trying to make sure that we've covered every avenue, every aspect, every profession, every resident, and giving

everybody the opportunity to participate in the process and really take a look at this stuff. So we appreciate your support. And unless there's anything else, I think it's time to say I hope everybody had a nice Thanksgiving, and we --

CHAIR CASTRO: -- we wish you happy holidays and a happy new year, because we will not see each other again until January. So I hope you and your families stay safe and enjoy it and have a happy holiday and a happy new year.
