Who We Are

The Commission on the Status of Women (CSW) is the principal global intergovernmental body exclusively dedicated to the promotion of gender equality and the empowerment of women. A functional commission of the Economic and Social Council (ECOSOC), it was established by ECOSOC resolution 11(II) of 21 June 1946.

The Broward County Commission on the Status of Women (CSW or Board) advisory board is a non-partisan body with a focus on raising awareness and celebrating the contributions and successes of all residents of Broward County. It especially provides a collaborative platform for those seeking information on issues that affect women, girls and their families in our county.

What We Do

CSW assesses County institutions, facilities, services and programs focusing on women or affecting women and their families, and recommends plans and programs to address these concerns. The Board:

- Identifies and helps resolve economic, health, social and other issues concerning women's lives through education and advocacy.
- Celebrates the achievements of women in Broward County by recognizing leaders including during Women's History Month annually in March.
- Holds annual events to bring organizations together and educates the public about the needs
 facing Broward County women. Through forums, round table discussions and other venue
 events, CSW provides invaluable feedback to the Broward County Commission consist with

COMMISSION MEETING HIGHLIGHTS

STATE OF THE COUNTY-Mayor Michael Udine

Chair Rogers introduced Broward Mayor Michael Udine, who spoke about the state of the County and the need to develop a community that embraces diversity. He also addressed affordable housing and how ad valorem taxes are used toward this along with the Commissioners' work to raise the Living Wage. Next, he touched on the importance of mental and physical health and expanding the County's services in these areas. The Mayor also serves on the Canvassing Board and spoke about voter education especially with mail-in ballots. Finally, he spoke about the need for infrastructure resiliency and the effects of sea level rising (many canals are at a critical point resulting in longer drainage times). Mayor Udine took questions from Board Members and stated that he welcomed the opportunity to speak at another meeting later in the year.

COUNTY UPDATE - Senator Nan Rich, current Broward County Commissioner

Chair Rogers introduced Senator Nan Rich and asked her about her priorities as they related to women in Broward County, and how the CSW could support the commission's goals. She spoke about her top priority of Affordable Housing and how we don't have some of the advantages of Miami-Dade County, such as a surtax. as well as how to use the Sadowski Fund and other general fund monies. Senator Rich explained that additional funds will be available in coming years as the Commission has agreed to add 50% of the funds from the CRA, which is "sunsetting." The results of the Census will determine how they proceed (the data is currently being compiled by staff at FAU). Furthermore, she noted that \$47 million in funds will also become available from the Federal Infrastructure; therefore, several affordable communities are being planned even though the County is reaching buildout. The Senator also spoke about the unconscionable increase in rents and other fees and their efforts to pass an ordinance against this. There are, however, a several developments that have been constructed recently, including for homeless and a 200-unit complex in Pembroke Pines, and one in Wilton Manors for senior residents. She stressed that they are always looking for other "shovel ready" projects

Senator Rich went on to talk about the Alimony bill which presumes that children should spend equal time (6 months each) with both parents. The Senator felt this should be up to a Family Court Judge and urged everyone to ask the Governor to veto it. Finally, she spoke about the CEDAW ordinance which was to be reviewed every other year like Miami-Dade's, and thus this is scheduled for 2023.



Finally, the CSW shared plans for increasing the awareness of the Board Meetings with the public and working on ways to host events to engage with the community. Sen. Rich suggested she work with her office as she would like the CSW to have a higher profile as well.



COMMITTEE REPORTS

WOMEN'S ISSUES – Chair Jasmen Rogers

Chair Rogers was active in mobilizing around the state, including a visit to Tallahassee regarding restrictions on abortion access. She has been able to discuss these activities with the board.

WOMEN'S VOTE- Chair TBD

 of Elections Joe Scott of Broward, and Wendy Sartory Link from Palm Beach County. Members

- This year the Broward County Commission on the Status of Women hosted Supervisor of Elections Joe Scott. Mr. Scott emphasized the importance of getting your vote in either early or though Vote by Mail. He discussed the plans for increasing drop boxes in the county in the coming year, to make it easier to get the ballots in on time. - With the election season in full swing, Supervisor of Elections outlined his plans to make voting
 accessible to everyone. The Broward CSW encouraged women to get out to vote through social
 media. There was also discussion about whether women in South Florida were more engaged due
 to the issues of reproductive freedom being on the ballot.





COMMISSION ON THE ELIMINATION OF ALL FORMS OF DISCRIMINATION AGAINST WOMEN (CEDAW) – Chair Julie Carson

On November 5, 2019, the Broward County Board of County Commissioners unanimously voted to approve the enactment of Ordinance 2019-35, creating Article V, Sections 16 ½ -81 and 16 ½ 82, of the Broward County Code of Ordinances, adopting the United Nations' Convention on the Elimination of All Forms of Discrimination Against Women (CEDAW). CEDAW provides an international standard for protecting and promoting women's human rights and is frequently referred to as the "Bill of Rights" for women.

The Status of Women in Broward County Report 2021 was presented to the Broward Commission by Commissioner Nan Rich at the March 9th, 2021 meeting. Commissioner Rich tasked the Broward CSW with finding solutions and bringing those to the Broward Commission.

The Committee under Chair Carson has been reviewing the report. The recent overturning of Roe v. Wade and how it disproportionately affects women of color and lower economic means should be addressed. Another statistic that needs attention is affordable housing as Senator Rich spoke about at the last meeting.

Each report spans 2 years, with the next report expected in 2023. A copy of the report can be requested through the board coordinator – Chad Zurko at czurko@broward.org.






BROWARD WOMEN AT THE COMMISSION

and ensuring their safety, well-being and positive development is a priority and a responsibility that we all share; and

WHEREAS, 1 in 3 women and 1 in 4 men have been victims of physical violence by a close partner within their lifetime; and

WHEREAS, the exposure of young children to such violence is occurring at an alarming rate. The U.S. Advisory Board on Child Abuse and Neglect suggests that domestic violence may be the single major precursor to child abuse and fatalities in this County; and

WHEREAS, LGBTQ+ individuals are found to be far more vulnerable and at risk to domestic violence and abuse than those engaged in heterosexual relationships; and

WHEREAS, the Broward County Commission on the Status of Women advisory board is a non-partisan body which provides a collaborative platform for those seeking information on issues affecting, women, girls, and their families in our county; and

WHEREAS, by providing individuals with education about healthy relationships, and by changing attitudes that support violence, we work to stop domestic violence for Broward County residents; NOW, THEREFORE,

BE IT PROCLAIMED BY THE BOARD OF COUNTY COMMISSIONERS OF BROWARD COUNTY, FLORIDA:

That the Board hereby designates, October 2022, as "DOMESTIC VIOLENCE AWARENESS MONTH" in Broward County, Florida and urge everyone to respond and work toward ending domestic violence by supporting their communities' efforts to empower and assist victims in finding and accessing the resources they need, and by promoting awareness and prevention of domestic violence.









MEMBERS IN THE COMMUNITY

CSW Board members represent an intersection of industries, interests, and expertise. We are proud of our members who participate in several other ways throughout the county.

- ➤ Broward CSW Board member Susan Buzzi received a grant from Cultural Committee to produce artwork on Domestic Violence. Susan Buzzi and Commissioner Michael Udine held a reception for the kickoff of National Domestic Violence Awareness Month in October.
- Dr. Udaya Thomas, drafted a statement, with input from other mindfulness practitioners on the benefits of mindfulness meditation in the context of increasing public safety, available evidence based research, and potential actionable steps. She presented it to the CSW to read for consideration to adopt.
- ➤ Dr. Thomas was an advisor to the grant-funded project, Juneteenth for Joy, and co-presented the project in a plenary session at the national Integrative Medicine for the Underserved (IM4US) 2022 Conference.
- ➤ Ms. Toby Feuer reported that one of the organizations she belongs to, the American Association of University Women (AAUW), sponsored eight \$1000 STEM scholarships for area high school students to attend college.
- ➤ Ms. Susan Buzzi reported that last month she attended a Human Trafficking Academy at St. Thomas Law School. She had also sent out an invitation for her exhibit on Domestic Violence, which opened in September.
- ➤ Ms. Linda Gonzalez participated in receiving proclamations related to gun safety awareness sponsored throughout the year by the League of Women Voters and by Moms Demand Action on Gun Safety.
- ➤ Elaine Blattner, Emma Collum, Nancy Fry and Linda Gonzalez participated in multiple community Voter Registration programs throughout the year.
