For Building Code Appeals, complying with the "voluntarily" cut-off date is strongly recommended so as to give all parties sufficient time to make arguments in writing and have included in the Agenda packet. However the later "mandatory" appeals cut-off date will be honored.

** All materials for the Board are included in the Agenda Packet. No handouts are permitted at the meeting. A letter from the Building Official rejecting the applicant's appeal must be included in the appeal packet submitted to the Board of Rules and Appeals.
