However the later "mandatory" appeals cut-off date will be honored.

** All materials for the Board are included in the Agenda Packet. No handouts are permitted at the meeting. A letter from the Building Official rejecting the applicant's appeal must be included in the appeal packet submitted to the Board of Rules and Appeals.
