Item 19 Capital Improvements Element - Five-Year Capital Program

The Board took under discussion, the Five-Year Capital Program from the Capital Improvements Element proposed amendment; mentioned its approval of the United States District Court Southern District of Florida's Stipulation for Entry of Consent Decree at its regular meeting of August 9, 1994 and questioned whether the criminal justice reform ought to be included in the Capital Improvements Element.

ACTION: (A-994) The Board directed the County Attorney's Office to investigate whether the criminal justice reform could be included in the Capital Improvements Element's Goal, Objectives and Policies proposed amendment and report back to the Board. Furthermore, the Board requested that the County Attorney's Office review the Corrections/Criminal Justice element and not include other issues pertaining to Emergency Medical Services and Fire Safety.

Item 20 Amtrak Reauthorization Bill - TCRA

The Board took under discussion a letter dated August 8, 1994 from Tony Cannestro, Teamsters Local Union Number 769 regarding opposition to the Amendment of the Amtrak Reauthorization Bill to expand railroad labor laws.

ACTION: (C-2595) The Board directed the County Attorney's Office to write a letter to the Senate Commerce Committee, the Broward County Legislative Delegation and Mr. Gil Roberts, Tri-County Commuter Rail Authority opposing the Amendment of the Amtrak Reauthorization Bill to expand railroad labor laws.
