

## PUBLIC HEARING OF JANUARY 10, 2006

(Meeting convened at 2:00 p.m. and adjourned at 4:23 p.m.)

### CALL TO ORDER

1. MOTION TO ADOPT Resolution 2006-17 of the Broward County Board of County Commissioners amending Section 24.50 of the Broward County Administrative Code, the title of which is as follows:

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF BROWARD COUNTY, FLORIDA, AMENDING SECTION 24.50, BROWARD COUNTY ADMINISTRATIVE CODE, PROVIDING FOR CHANGES IN MAXIMUM FEES FOR RECOVERING, TOWING, REMOVING, OR STORING VEHICLES REMOVED FROM PRIVATE PROPERTY, PROVIDING FOR CHANGES IN MAXIMUM FEES FOR TOWING, REMOVING, OR STORING VEHICLES REMOVED FROM OTHER THAN PRIVATE PROPERTY, INCLUDING TOWS DIRECTED BY LAW ENFORCEMENT OR OTHER MUNICIPAL AGENCIES, PROVIDING FOR SEVERABILITY; PROVIDING FOR INCLUSION IN ADMINISTRATIVE CODE; AND PROVIDING FOR AN EFFECTIVE DATE.

A RESOLUTION OF THE BROWARD COUNTY BOARD OF COUNTY COMMISSIONERS, AMENDING SECTION 37.2 OF THE BROWARD COUNTY ADMINISTRATIVE CODE; PROVIDING FOR A MINIMUM TAXI FARE WHEN PASSENGERS ARE PICKED UP FROM THE FORT LAUDERDALE-HOLLYWOOD INTERNATIONAL AIRPORT AND PORT EVERGLADES SEAPORT; PROVIDING FOR SEVERABILITY; PROVIDING FOR INCLUSION IN THE ADMINISTRATIVE CODE; AND PROVIDING FOR AN EFFECTIVE DATE.
