

PUBLIC HEARING OF FEBRUARY 11, 1997

1. MOTION TO ADOPT Resolution 97-104 authorizing the exchange of county property rights with property rights owned by The Howard Levinson Revocable Trust Agreement in accordance with provisions of Section 125.37 of the Florida Statutes. (Parcel 96-5)

2. MOTION TO ADOPT Resolution 97-105 to vacate and abandon road right-of-way lying and being in Broward County, Florida and located at 5400 Northwest 57 Avenue in the City of Coral Springs. Petitioner: WCI Communities Limited Partnership (Patricia Hitchcock - Agent) 15-V-93.

AN ORDINANCE OF THE BOARD OF COUNTY COMMISSIONERS OF BROWARD COUNTY, FLORIDA, AMENDING CHAPTER 20, ARTICLE XVII, OF THE BROWARD COUNTY CODE; AMENDING DEFINITIONS; PROVIDING FOR A CABLE TELEVISION LICENSE; PROVIDING FOR A LICENSE FEE AND PUBLIC PROPERTY CHARGE FOR USE OF PUBLIC RIGHT-OF-WAYS TO BE SET BY RESOLUTION; PROVIDING HOUSEKEEPING CHANGES; AMENDING SECTION 8½-16 RELATING TO PENALTIES; PROVIDING FOR SEVERABILITY, INCLUSION IN CODE, AND PROVIDING FOR AN EFFECTIVE DATE.
