AN ORDINANCE OF THE BOARD OF COUNTY COMMISSIONERS OF BROWARD COUNTY, FLORIDA, AMENDING THE ORDINANCE PROVIDING FOR A PREFERENCE FOR BIDDERS OR PROPOSERS IN ORDER TO REPEAL THE SUNSET CLAUSE WHICH WOULD CAUSE THIS ORDINANCE TO SUNSET ON JULY 12, 1994; PROVIDING FOR SEVERABILITY; PROVIDING FOR INCLUSION IN CODE; AND PROVIDING FOR AN EFFECTIVE DATE.
