CALL TO ORDER

- MOTION TO ADOPT supplemental budget Resolution 2000-1170 within the General Fund in the amount of \$138,477 to amend revenues and appropriations prior to the close of the fiscal year.

ACTION: (B-0295) Approved.

- MOTION TO ADOPT supplemental budget Resolutions 2000-1171 and 2000-1172 within the Special Purpose sub-funds of the General Fund in the amount of \$1,637,924 to amend revenues and appropriations prior to the close of the fiscal year.

- MOTION TO ADOPT supplemental budget Resolution 2000-1173 within the Tourist Development Fund (1070) in the amount of \$216,392 to reimburse the tourist development fund for tourist taxes transferred to the general fund in the prior fiscal year.

- MOTION TO ADOPT supplemental budget Resolution 2000-1174 within the Trust and Agency Funds in the amount of \$56,131 to amend revenues and appropriations prior to the close of the fiscal year.

AN ORDINANCE OF THE BROWARD COUNTY BOARD OF COUNTY COMMISSIONERS AMENDING SECTION 9-12 OF THE BROWARD COUNTY CODE OF ORDINANCES, "RECIPROCAL CERTIFICATION," TO PROVIDE FOR THE RECIPROCATION AND ISSUANCE OF BROWARD COUNTY'S LIQUEFIED PETROLEUM GAS CONTRACTOR AND INSTALLATION CONTRACTOR CERTIFICATES OF COMPETENCY FOR PERSONS LICENSED BY THE STATE OF FLORIDA; AMENDING SECTION 9-41, "CENTRAL EXAMINING BOARDS CREATED," PROVIDING FOR THE CREATION OF SIX CENTRAL EXAMINING BOARDS; AMENDING SECTION 9-42, "MEMBERSHIP, APPOINTMENT, QUALIFICATIONS AND TERMS," INCREASING THE NUMBER OF BOARD MEMBERS AND INCLUDING CONSUMER REPRESENTATIVES; PROVIDING FOR SEVERABILITY; PROVIDING FOR INCLUSION IN THE CODE; AND PROVIDING FOR AN EFFECTIVE DATE.

AN ORDINANCE OF THE BOARD OF COUNTY COMMISSIONERS OF BROWARD COUNTY, FLORIDA, CHANGING THE ZONING DISTRICT BOUNDARIES BY REZONING A PORTION OF SECTION 31, TOWNSHIP 50 SOUTH, RANGE 41 EAST, BROWARD COUNTY, FLORIDA; FROM A-1, AGRICULTURAL ESTATE DISTRICT TO RE, RURAL ESTATE DISTRICT; PROVIDING FOR AMENDMENT OF THE ZONING DISTRICT MAPS; PROVIDING FOR THE REPEAL OF ALL REZONING ORDINANCES AND ZONING RESOLUTIONS IN CONFLICT HERewith; PROVIDING THAT THIS REZONING SHALL NOT BE CONSTRUED TO CREATE A RIGHT TO DEVELOPMENT THAT FAILS TO MEET THE REQUIREMENTS OF OTHER LAND DEVELOPMENT REGULATIONS; PROVIDING FOR SEVERABILITY; AND PROVIDING FOR AN EFFECTIVE DATE.
