

RESOLUTION NO.

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF BROWARD COUNTY, FLORIDA, AMENDING CHAPTER 37, PART IV, OF THE BROWARD COUNTY ADMINISTRATIVE CODE; PROVIDING A REVISED PARK SYSTEM FEE SCHEDULE COMMENCING FY 2010; PROVIDING FOR SEVERABILITY; PROVIDING FOR INCLUSION IN THE BROWARD COUNTY ADMINISTRATIVE CODE; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, it is the desire of the Broward County Board of County Commissioners to amend Chapter 37, Part IV, of the Broward County Administrative Code relating to Broward County Park System Fee Schedule commencing FY 2010; and

WHEREAS, the revised fee schedule commencing FY 2010 is reasonable and necessary; NOW, THEREFORE,

BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF BROWARD COUNTY, FLORIDA:

Section 1. That the Board of County Commissioners of Broward County, Florida, hereby amends Volume III, Chapter 37, Part IV, of the Broward County Administrative Code, as provided for herein and adopts and institutes the amended fee schedule commencing FY 2010 as set forth in Exhibit "A," attached hereto and incorporated herein.

Section 2. SEVERABILITY.

1 If any portion of this Resolution is determined by any Court to be invalid, the  
2 invalid portion shall be stricken, and such striking shall not affect the validity of the  
3 remainder of this Resolution. If any Court determines that this Resolution, or any  
4 portion hereof, cannot be legally applied to any individual(s), group(s), entity(ies),  
5 property(ies), or circumstance(s), such determination shall not affect the applicability  
6 hereof to any other individual, group, entity, property, or circumstance.

7 Section 3. INCLUSION IN ADMINISTRATIVE CODE. It is the intention of the  
8 Board of County Commissioners that the provisions of this Resolution shall become and  
9 be made a part of the Broward County Administrative Code; and that the sections of this  
10 Resolution may be renumbered or relettered and the word "resolution" may be changed  
11 to "section," "article," or such other appropriate word or phrase in order to accomplish  
12 such intentions.

13 Section 4. EFFECTIVE DATE.

14 This Resolution shall become effective October 1, 2009.

**37.32. General.**

The Board of County Commissioners of Broward County, Florida, adopts and institutes the following amended fee schedule set forth below for the Broward County Parks and Recreation Division ~~for FY 2009 commencing FY 2010.~~ Programs sponsored or co-sponsored by the Broward County Parks and Recreation Division are exempt from the payment of fees set forth in this fee schedule. Programs sponsored by non-profit organizations (registered with the State of Florida or designated as an Internal Revenue Code Section 501(c)(3) corporation), other governmental entities, and private entities are required to pay the fees set forth in this fee schedule.
