1. **SCOPE:**
In accordance with the applicable Florida State Statute and the Purchasing Division Internal Control Handbook, Chapter 15, the equipment cited herein has been declared surplus to the needs of Broward County and is hereby offered for sale to the highest bidder.

The Bid Sheet(s) is to be returned to the Purchasing Division.

2. **SUBMISSION OF BIDS: HOW, WHEN AND WHERE:**
Sealed Bids will be received by the Purchasing Division of Broward County until 2:00 p.m., Tuesday, August 22, 2006. All Bids, either mailed or walked in, will be received at the Purchasing Division, 115 South Andrews Avenue, Room 212, Fort Lauderdale, Florida 33301. All bids must be received in a sealed envelope marked on the outside as follows:

3. **FURTHER INFORMATION:**

The items may be inspected by appointment only between the hours of 8:00 a.m. to 5:00 p.m., excluding holidays.

4. **CONDITION OF SALE:**
The items offered for sale on an "as is" basis and the County offers no guarantee or warranty, expressed or implied, as to their operational or physical condition. The cost of the removal of the items from the County's premises is to be borne by the successful bidder. All sales will be final.

Successful bidder must use its own equipment in loading purchased goods. All the items must be picked up. Bidders are encouraged to view the items prior to submitting a bid.

Successful bidder is responsible for ensuring compliance with all pertinent federal, state, and local requirements including but not limited to licensing, insurance, and permits relative to the removal of the subject items.

Failure of the successful bidder to remove all awarded items within the prescribed period of time may result in the bidder being restricted from participating in future County surplus bids/or quote.

5. **BASIS OF AWARD:**

Broward County Board of County Commissioners, reserves the right to make awards by the highest quote for each lot.

The County reserves the right to waive technicalities and irregularities, and accept the quote deemed most advantageous, or to reject any or all quotes.

Preference may be given to quote submitted by government agencies located within Broward County for items included in the quote. This preference may include the awarding of this quote to a government agency despite the fact that the quote may not be the highest received by the County.

6. **SPECIAL TERMS AND CONDITIONS:**

There is a minimum acceptable bid amount for the radios. See attached Bid Sheets.

7. **TERMS AND PROVISIONS:**

Buyer hereby agrees to indemnify and save harmless the County, its commissioners, officers, agents and employees, from or on account of any injuries or damages received or sustained by any person or persons during or including, without limitation, the removal of any property purchased by the Buyer from the County and/or the sale by Buyer of any such property to third parties; or by consequence of any negligence of Buyer, its subcontractors, employees or agents in connection with same; or on account of any defect in the operation or physical condition of any such property; or on account of use of any improper materials by or any act or omission of the Buyer, its subcontractors, agents or employees. Buyer hereby agrees to indemnify and save harmless the County, its commissioners, officers, agents and employees, against any claims or liabilities, arising from or based upon the violation of any federal, state, county or local laws, ordinances or regulations by the Buyer, its subcontractors, agents or employees.

These indemnifications shall survive the conveyance of any properties to the Buyer. In the event any action or proceeding is brought against the County by reason of any such injury, damages, claim or liability, Buyer, upon written demand from the County, at Buyer's sole expense, shall resist and defend such action or proceeding by counsel satisfactory to the County.

All property is sold "as is" and where is". The County makes no warranties or guarantees expressed or implied to the operation or condition of any piece of equipment.

ALL SALES ARE FINAL. NO REFUNDS. NO EXCHANGES.

Successful bidder agrees to comply with all terms and provisions as listed above.

8. **TERMS OF SALE:**

The amount due from the successful bidder must be paid in full by governmental check, cash, certified check, or cashier's check made payable to the "Board of County Commissioners, Broward County, Florida" within thirty (30) calendar days following written notification of award.

If the successful bidder fails to make payment within thirty (30) calendar days from date of Notification of Award, the County reserves the right to award the items to the second high bidder or dispose of the item(s) in accordance with the County Procurement Code.

Notification of Award will contain instructions regarding payment and pick up procedures. Removal and payment of property must be completed within thirty (30) calendar days from date of Notification of Award.

NOTE:

If the successful bidder fails to remove item(s) within thirty (30) calendar days from Notification of Award, the County reserves the right to award the items to the second high bidder or dispose of the item(s) and the bidder may forfeit any monies paid to the County.

THE FAILURE OF THE SUCCESSFUL BIDDER TO MAKE PAYMENT WITHIN THE PRESCRIBED PERIOD OF TIME MAY RESULT IN THE BIDDER BEING RESTRICTED FROM PARTICIPATING IN FUTURE COUNTY SURPLUS BIDS/OR QUOTES.

9. **SALES TAX:**

The amount due will be the total bid amount plus 6% State Sales Tax with the exception of governmental entities and/or tax exempt entities. Tax exempt non-governmental entities should provide tax exemption certification with their bid.

10. **OTHER CONDITIONS:**

Bids may not be withdraw for a period of ninety (90) days after due date. Withdrawal of bid after this period must be in the form of a written notification to the Purchasing Director, and can be submitted only if any award of contract has not been made within this ninety (90) day time period.
