\_\_\_\_\_ A letter from the Engineer or Architect of Record stating the actual construction costs of the FACILITIES with material takeoff and unit pricing.

\_\_\_\_\_ A Bill of Sale Absolute for all of Permittee right, title and interest to the FACILITIES.

\_\_\_\_\_ An Affidavit that all persons, firms, or corporations who furnished labor or materials used directly or indirectly in the prosecution of the work required to be performed by this Permit have been paid.

\_\_\_\_\_ A Release of Lien from all contractors and suppliers of materials and/or labor who might have acquired interest in the FACILITIES by the supplying of materials and/or labor.

\_\_\_\_\_ A Final Release of Liens releasing all liens which Permittee might have on the FACILITIES.

\_\_\_\_\_ Easement documents acceptable to WWED giving a perpetual right, easement and privilege to operate, maintain, repair, replace or add to water and wastewater facilities including Legal Description and Sketch signed and sealed by a Florida Registered Professional Surveyor and Mapper; and secure from each mortgagee and lienor a release of mortgagee's and lienor's interest in the property and fixtures thereon. An up to date Title Opinion is required to document mortgagee's and lienor's interest.

\_\_\_\_\_ The Florida Department of Health Certification Clearance.

\_\_\_\_\_ The Florida Department of Environmental Protection Request For Approval To Place A Domestic Wastewater Collection/Transmission System Into Operation.

\_\_\_\_\_ Record Drawings meeting WWED's current "Minimum Design and Construction Standards" and "Minimum Drawing Requirements for Water and Sewer Line Projects".

\_\_\_\_\_ All manufacturer's warranties which Permittee might have received or is due to receive related to lift stations, meters, control valves or as otherwise requested by WWED.

\_\_\_\_\_ A one (1) year warranty bond covering all FACILITIES.
