Ms. Allison Bruchwalski was appointed by Commissioner Hazelle Rogers. Ms. Tonya Wesley Pile was appointed by Commissioner Rober McKenzie. They briefly introduced themselves and shared why they chose to join this Board.

Medication Assisted Treatment (MAT) - Client/Family to Provide Testimonial

Dr. Dale Fahie, Medical Director, provided a brief overview of the Division's Medication Assisted Treatment (MAT) unit and introduced Ms. Barbara Mitchell, Licensed Practical Nurse and William Derby, Behavioral Health Clinician, who work closely with MAT clients.

Dr. Fahie explained that the program utilizes FDA-approved medications, counseling, and behavioral therapies to treat substance use disorders, including opioid use disorders. The program aims to help individuals stabilize, reduce cravings, prevent relapses, and improve overall recovery.

Two clients shared their positive experiences with the program, highlighting its effectiveness in managing withdrawal symptoms, reducing cravings, and facilitating a return to a productive life. A family member also shared the profound impact on the entire family, fostering stronger bonds, increasing everyone's well-being, leading to a more resilient and supportive family unit.

Division Report

Ms. Vanessa Major, Assistant Division Director, discussed the activities and successes of the BARC Outreach Team.

The Outreach Team has been very busy attending the Marchman Court and all Community Courts, including Hollywood, Fort Lauderdale, and Pompano Beach. Additionally, they have attended resource fairs and several school presentations.

They recently began joining the First Baptist Church of Pompano on the first Saturday of each month for their community engagement initiative. During April 5, 2025, event the team brought in three clients for detoxification after being assessed in the field. The Team was able to complete the majority of the admissions process prior to the client's arrival at the Central facility by coordinating with BARC's medical staff. Since BARC's Outreach Team started, they have brough 99 clients in for detoxification.

Ms. Eleanor Nelson-Wernick, discussed her experience when she recently joined an outreach event on February 4, 2025, at the Pompano Bus Terminal. She found the event to be very well coordinated with other agencies. She was able to observe BARC staff's substantial commitment to assisting the homeless, providing minor medical care, assessing mental health, and encouraging them to seek treatment if appropriate.

Ms. Major also reported

- The Division successfully completed two audits (one with BBHC and one with DCF), during the past couple of months.
- BARC has renewed all DCF licenses. The Division is awaiting a final walkthrough for a new Outpatient license for BARC Central.
- Everything is status quo for the Opioid Settlement Funds.
- A new Electronic Health Record system was recently approved after a lengthy purchasing process. The system is Arize from Cantata Health Solutions and initialization is expected to occur in July or August.
- The County has introduced an additional step in the hiring process. For each vacant position the Division must submit a justification for filling critical positions. These justifications must be reviewed and approved by the Human Resources Division and County Administrator's Office.
