Runways

Two of the runways are lighted for 24-hour operation.

- 1. **10R–28L** is 3,225 feet long with pilot controlled medium intensity lighting for 24-hour operation.
- 2. 10L-28R is 3,241 feet long.
- 1L-19R is 3,350 feet long with pilot controlled medium intensity lighting for 24-hour operation.
- 4. 1R-19L is 3,260 feet long.

Acreage

511 acres

Aircraft Storage

150 T-Hangars and over 200 tie-down spaces for aircraft storage.

Hours

The airport is open 24-hours. The Air Traffic Control Tower operates from 7AM to 9PM daily.

Aircraft

400 aircraft are based at the airport. Aircraft operating at HWO are limited to maximum take-off weight of 12,500 pounds.

Aircraft Operations

More than 200,000 take-offs and landings in 2017. Seventy-five percent of these operations are flight training activities from eight flight schools.

- Eight flight schools
- Two banner towing operators
- News/helicopter operators
- Five maintenance facilities
- Four fixed based operators offering both AvGas and/or Jet A fuel

Economic Impact

The Florida Department of Transportation (FDOT) completed a comprehensive economic impact analysis in 2014 for North Perry Airport (HWO). The FDOT estimated HWO has an \$83 million annual impact on the community. HWO also generates about 900 total jobs (direct and indirect).

History

- In 1943, the U.S. Navy constructed HWO for use as a satellite training field in connection with flight training activities at Miami Naval Air Station.
- After World War II, it was inactive until 1956 when Broward County acquired the airport from the U.S. Navy.
- HWO is a general aviation airport devoted exclusively to private and business light-plane activity.

Recognition

- 2008 and 2013 General Aviation Airport of the year by the FDOT.
- 2010 Federal Aviation Administration Runway Safety Award.
- HWO has been named the busiest contract tower airport in the State of Florida.
