

PREMO Newsletter Initial Corridors Summary

October 2022

Broward County Transit (BCT) is developing the Premium Mobility Plan, or PREMO. PREMO will define a vision for a world-class premium transit network in Broward County that provides modern, convenient, attractive, safe, reliable, and frequent mobility options. To achieve this vision, PREMO strategically identifies a program of projects that sequences the implementation of premium transit services — connecting local BCT routes to regional services. Examples of premium transit include bus rapid transit (BRT) or light rail transit (LRT).

What is PREMO? PRE—mium MO—bility for all

BUS RAPID TRANSIT • BRT



Bus Rapid Transit, or BRT, is high quality busbased transit that uses modern vehicles and often dedicated lanes or technology to provide faster, more reliable service.

LIGHT RAIL TRANSIT • LRT



Light Rail Transit, or LRT, is passenger rail that uses modern rail cars in urban areas, often in dedicated lanes to provide frequent, reliable service.

PREMO Goals

The following goals are the foundation for PREMO. The goals were developed collaboratively with the Project Advisory Group (PAG), leadership, and agency staff.

Improve Mobility for All Implement Equitable Transit Solutions Improve Safety, Security, and Ensure Environmental Stewardship Enhance Economic Development and Ensure Financial Stability

PREMO Process

PREMO began by identifying mobility trends and premium transit needs in Broward County, focusing on major roadways where premium transit investments can be made. This is followed by a series of steps to develop a sequenced program of projects. Projects will be sequenced based on how well they meet the goals of PREMO and the needs of the public, through a step-by step technical analysis coupled with robust and meaningful public involvement.

PREMO will look at "where" to locate premium transit, "what" it will look like, and "how" it can be built:

Steps A through **C** will look at **WHERE** the best premium transit corridors are located



How well does the corridor connect to communities and support growth?



Does the corridor provide mobility and equity benefits?



Does the corridor have the ability to attract more riders?

Step D will look at **WHAT** type of transit service works best to create a project



What type of transit would serve the corridor best?

Steps E and **F** will look at **HOW** the projects can be built



How can each project be built?



What is the sequence of projects?

What is the schedule?

The PREMO Plan is ongoing and will conclude in Winter '22 to '23 with adoption by the Broward Board of County Commissioners.

PREMO Starting Point: Defining the Initial Network




PREMO's purpose is to develop a premium transit vision resulting in a sequenced program of projects. PREMO will "bridge the gap" and connect local transit to regional transit services. The Initial Network contains the candidate corridors for premium transit and serves as the starting point for PREMO. To develop the Initial Network, PREMO

focused on major roads, primarily the east-west

and north-south arterials.

Defining the Initial Corridors

"How well does the corridor connect to communities and support growth?"



The next step in PREMO's development was to identify the Initial Corridors. The Initial Corridors are those that Connect to Communities and Support Growth. To answer this question, corridors were evaluated against PREMO goals. A snapshot of the characteristics evaluated for each corridor includes:

PREMO Goal	Step A Evaluation Characteristics
Mobility for All	» Serves existing riders or high ridership routes
Implement Equitable Transit Solutions	» Provides access to housing
Integrate with and Serve Communities	 » Serves existing and future jobs and residents » Serves major activity and community centers (schools, medical centers, public facilities)
Enhance Economic Development and Ensure Financial Sustainability	 » Serves future housing » Has potential for future growth » Supports and is supported by premium transit



Defining the Shortlisted Corridors "How well does the corridor provide mobility and equity benefits?"



The next step of PREMO's development is defining the Shortlisted Corridors. This step evaluates each potential premium transit corridor's ability to provide **Mobility and Equity Benefits**. To answer this question, the focus of this step will be to evaluate:

- » How investing in premium transit can improve access to affordable housing, activity centers, and jobs
- » How investing in premium transit can improve access to jobs and housing
- » How investing in premium transit can impact congested corridors
- » How PREMO can connect to bicycle and pedestrian facilities
 - » How investing in premium transit can positively impact underrepresented and transit dependent communities


The website houses information about PREMO and links to the latest survey and interactive map. As PREMO development continues, additional documents will be added, allowing the community stay updated on the progress.
