➤ Broward County Ordinance Chapter 3 ½	T. DiBernardo stated that county commissioners did not accept any of Executive Board's changes. Chairman and T. DiBernardo were present. The county commissioner did not accept any of our changes. This had to do with data collection. Afterwards fire chief association asked what was going on. They then had the Mayor to go over all of the Executive Board's changes and a better understanding developed between the committee and the Mayor. The ordinance is in effect. With data collection everything should be revealed; some of it may be so challenging it is not be attainable. T. DiBernardo feels positive but not we're not there. Part of ordinance was to hire someone to do the data collection and then Dr. Mallak received the hiring freezes. The County Administrator offered to come here. The committee wants to meet with commissioners and County Administrator prior to anything that goes before the commission.

There are about a half dozen Council members at this meeting. The website is www.firsttherefirstcare.com.</p> <p>Conference dates: June 6, 7, 8, 2017. Location: Bonaventure Resort and Spa, in Weston. The location moved from the Hard Rock, Hollywood this year because of construction.</p> <p>Support from the sponsors and donors, along with sponsorship and EMS grant and seed money from prior years, enabled the conference to meet their goals.</p> <p>The Committee is has not finalized all speakers and the agenda, but should be finished by the end of the month. Tammie Nugent and Vanessa Quiles are working on the speakers committee.</p> <p>Day 1, June 6, is going to be same format as last few years. We are going to have ALS and Nursing team preliminary competitions. That’s all that is taking place on June 6. But the ALS and nursing finals take place on Wednesday.</p> <p>On Wednesday, June 7, pre-conference lectures will start about 8:30/9:00. The plans include four rooms of lectures. Some speakers include Eric Clause, Keynote Speaker, a Nurse Paramedic from Virginia, who is very experienced on the subject of suicide. Speaker, Dr. Pepe, will be doing a half-day seminar and Mary Van Hoot, a full day. Other speakers will present a full day on leadership and training for paramedics, nurses and ALS, and a group will lecture on safety and self-defense for a medics and ER nurses.</p> <p>The Fire Chiefs’ Association will host the SE Region Fire Chiefs, chaired by Miami-Dade Fire Chief. 	<p>competition awards will take place in vendor's area followed later, 7:00-10:00 pm, by the second annual EMS party.</p> <p>The big day is Thursday, June 8 beginning at 8:30 with the opening ceremony for the conference.</p> <p>Tammy Nugent gave an update on the conference speakers. The keynote speaker, Eric Clause, will lecture on the health and wellness of all our providers. There will be a panel discussion, focused on lessons learned, which includes a trauma surgeon and nurse, emergency manager from Orange County, a hospital emergency manager, and a fire chief. Additionally, a panel from the Fort Lauderdale shooting will present, depending on their level of clearance.</p> <p>Fire Chiefs' Association of Broward County and Broward Regional EMS Council are the main sponsors. This is an international event. Spots are opened for EMS providers and hospital providers. Almost all contracts are signed.</p> <p>Dr. Lee asked question on CMEs for physicians. At this time, due to only few doctors who attend, and the requirements involved, it didn't warrant offering credits. The committee is considering it for next year.</p> <p>Any questions call R. ❖ Legislature	<p>Announced that they are tracking Senate Bill 746 which deals with trauma care. Additionally, there is legislation for fire fighters, who according to University of Miami research, are five times as likely to be diagnosed four types of cancers. Other legislations include some funding for volunteer fire rescue; another for claimants to receive compensation for PTSD.</p>	
❖ Medical	<p>In January teams began focusing on better response time to hospitals. Another issue brought up by T. DiBernardo mention there were two incidents, regarding trauma medical records and HIV testing, where the hospital was not working with EMS. They are looking at these as isolated incidents but are continuing to monitor them.</p>
