Marcia spoke on behalf of the BHC during yesterday's Broward Housing Days meeting. Registration is open for Broward Days 2022 scheduled in Tallahassee on January 18-19, 2022. The Build Back Better Act is worth \$150 million to Broward County for housing, if it passes the Senate. Please advocate for this legislation.

#### 5) Director's Report

Jo Sesodia, Director, Urban Planning Division (UPD), reported that the status of the Affordable Housing Needs Assessment Update has changed, and the project will now commence in March 2022 versus December 2021 to coincide with the projected release of the latest ACS data.

The Affordable Housing Dashboard, a BHC work program project, was presented by Chris Flynn, UPD Program/Project Coordinator, who noted that the Dashboard is live but not publicly released. The main page displays static information at the County level; however, data shown under the Supply, Affordability and Income tabs is more detailed and will be updated as additional data becomes available. BHC members will receive the Dashboard link via email, and staff requests that members access and interact with the Dashboard. Members are asked to not share the link at this time. # H.R. 5376: The Build Back Better (BBB) Act

2022 budget resolution (S. Con. Res. 14) uses the budget reconciliation process and tax reforms to make investments in post-disaster recovery addressing physical, social, environmental and economic vulnerabilities.

November 19, 2021: House approved \$1.7 trillion in funding

#### Title IV, Subtitle A: Investing in Affordable, Equitable, Sustainable and Accessible Housing for the 21<sup>st</sup> Century

Total investment in affordable housing: **\$151B** 

- Expands access to affordable, accessible housing
- Assists 294,000 households in affording their rent
- Builds, upgrades and/or retrofits over 1.8 million affordable housing units
- Helps close the racial wealth gap through investments in homeownership for first-time buyers who qualify as socially or economically disadvantaged, and providing grants to minority owned businesses
- Eliminates National Flood Insurance Program debt

**Rental Assistance**: \$24 billion to fund incremental Housing Choice Vouchers and supportive services, of which \$7.1 billion is provided to serve people experiencing or at risk of homelessness or survivors of domestic violence and human trafficking; and \$1 billion to the Project Based Rental Assistance program.

**Repairing Public and Assisted Housing**: \$65 billion to address national public housing capital backlog; and \$1.6 billion to preserve/improve safety conditions in properties receiving Project-Based Rental Assistance.

#### Affordable Housing Investments:

- \$10 billion HOME program to preserve, create or retrofit affordable homes for low-income families;
- \$15 billion create and preserve affordable rental homes for the lowest income households;
- \$1 billion support development of affordable housing for seniors and people with disabilities;
- \$2 billion invest in rural rental housing; and
- \$2 billion energy efficiency and property resiliency grant program for property owners of federally assisted housing

**Community Development Block Grant (CDBG)**: \$3.05 billion for CDBG funding for affordable housing infrastructure, including allocations for predominately low-income rural communities and manufactured housing communities.

**Strengthen Resiliency Under the National Flood Insurance Program (NFIP)**: Forgives \$20.5 billion in NFIP debt; directs \$600 million to support flood mapping; and \$600 million for FEMA to establish a means-tested affordability program for NFIP policyholders with incomes up to 120% of AMI.

**Promote First-Generation Homeownership**: \$10 billion in down payment assistance for first-time homebuyers who qualify as socially or economically disadvantaged to help millions of Americans become homeowners and begin building wealth; and \$5 billion to subsidize 20-year mortgages for first-generation homebuyers.

Address Lead-Based Paint Hazards: \$5 billion to address lead-based paint and other health hazards in low income family housing

**Invest in Native American Communities**: \$1 billion to Native American, Alaska Native and Native Hawaiian communities to address most critical housing and community development needs.
