Jo Sesodia, Director, Urban Planning Division (UPD), reported that Broward County advisory boards will resume in-person meetings effective May 11, 2022. The CAO/Ethics Team will provide advisory board ethics training during the June 24 BHC meeting. The Board of County Commissioners April 26 meeting agenda includes a public hearing item (Item #51) regarding fair notice of rent increases which requires 60 days' notice by a landlord for rent increases of 5% or more; effective May 1, 2022, if adopted. Ms. Sesodia presented the latest updates to the Affordable Housing Dashboard. The results of the Affordable Housing Needs Assessment will be incorporated into the Dashboard, when available.

4) Vice-Chair's Report

Caryl Hattan, Vice-Chair, reported on the State's approved FY 2022-23 budget – \$112.1 billion, the largest in Florida's history – and the status of housing related legislation. A total of \$362.8 million was budgeted for affordable housing. Registration is still open for the Prosperity Partnership Housing Affordability Summit on May 5 at Broward College in Davie. BHC members are encouraged to volunteer to serve on the BHC Fall Workshop subcommittee. The workshop theme/topic and date TBD.
