Requested Action

<u>MOTION TO ADOPT</u> supplemental budget Resolutions within the Capital Fund in the amount of \$2,663,379 to reappropriate funds for prior year project commitments and to provide additional funds for other projects.

Why Action is Necessary

Supplemental budgets are required whenever existing revenue sources are increased or decreased, resulting in a change in the total appropriations of a fund.

What Action Accomplishes

The primary purpose of this supplemental budget is to reappropriate funds for prior year project commitments. This budget amendment also includes a number of proposed new appropriations to address issues that have arisen since the adoption of the Fiscal Year 2017 budget.

Previous Action Taken

None.

Summary Explanation/Background

Staff typically presents three supplemental budget amendments per year to the Board. The purpose of the first supplemental budget amendment is primarily to carry forward, or "reappropriate" funds, for specific non-recurring items which were unexpended at the end of the Fiscal Year. This budget amendment also includes a number of proposed new appropriations which are highlighted individually below.

GENERAL CAPITAL OUTLAY FUND - \$2,218,379 - Fund balance is reappropriated for the Emergency Operations Center transfer switch project (\$276,000) and the Hispanic Cultural Research Center project (\$1,396,159). These two projects could not be reappropriated administratively due to the number of years the projects were inactive from a financial perspective. Work on the Emergency Operations Center transfer switch started at end of Fisca. Year 2016. This project allows for a new hookup of a backup generator and an automatic switch to generator power. The Hispanic Cultural Research Center project was originally planned for the Main Library and was deferred for several

years as a result of ongoing construction at the facility.

In addition, fund balance is also appropriated to fund the following regional communications technology capital projects: \$209,220 in professional services to oversee the implementation of the Fire Rescue Paging project and \$237,000 for the Local Government Radio System project, primarily due to a change in vendor and need for additional hardware. \$100,000 is budgeted to fund a Countywide mass notification system to enable existing Voice Over Internet Protocol (VoIP) infrastructure to broadcast emergency notifications through telephone speakers. Funds budgeted primarily for detention maintenance projects are transferred to the General Fund to enable BSO to manage the projects (\$1,365,000).

CONSTITUTIONAL GAS TAX CAPITAL FUND - \$350,000 - Additional fund balance is appropriated to fund a traffic study in the area around the Arena to assist in determining the road improvements needed due to additional development, including another ramp to the Sawgrass Expressway.

BROWARD MUNICIPAL SERVICES DISTRICT CAPITAL FUND - \$95,000 - Fund balance is appropriated for the Station 23 renovation project to fund additional improvements needed due to unforeseen conditions disclosed during construction.
