

RESOLUTION NO. 2020-584

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF BROWARD COUNTY, FLORIDA, ADOPTING A FINAL MILLAGE RATE FOR THE BROWARD MUNICIPAL SERVICES DISTRICT COMPRISING THE UNINCORPORATED AREAS FOR FISCAL YEAR 2020-2021; AND PROVIDING FOR SEVERABILITY AND AN EFFECTIVE DATE.

WHEREAS, pursuant to the requirements of Section 200.065(2), Florida Statutes, the Board of County Commissioners of Broward County, Florida ("Board"), on September 22, 2020, held a public hearing on the final budget and millage rate for the Broward Municipal Services District comprising the unincorporated areas; and

WHEREAS, the Board desires to adopt a final millage rate for Fiscal Year 2020-2021 for the Broward Municipal Services District comprising the unincorporated areas, NOW, THEREFORE,

BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF BROWARD COUNTY, FLORIDA:

Section 1. The Board hereby adopts a final millage rate of 2.3353 for the Fiscal Year beginning October 1, 2020, and ending September 30, 2021. The final millage rate constitutes a 5.79 percent increase in property taxes as compared against a rolled-back rate of 2.2074.

Section 2. This Resolution shall be filed with the Broward County Division of Records, Taxes and Treasury and a certified copy forwarded to the Broward County

1 Property Appraiser, the Broward County Division of Records, Taxes and Treasury, and  
2 the State of Florida Department of Revenue.

3 Section 3. Severability.

4 If any portion of this Resolution is determined by any court to be invalid, the invalid  
5 portion will be stricken, and such striking will not affect the validity of the remainder of this  
6 Resolution. If any court determines that this Resolution, in whole or in part, cannot be  
7 legally applied to any individual, group, entity, property, or circumstance, such  
8 determination will not affect the applicability of this Resolution to any other individual,  
9 group, entity, property, or circumstance.

10 Section 4. Effective Date.

11 This Resolution is effective upon adoption.
