

RESOLUTION NO. 2024-588

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF BROWARD COUNTY, FLORIDA, ADOPTING A FINAL MILLAGE RATE FOR THE STREET LIGHTING SUBDISTRICT IN THE UNINCORPORATED AREA OF BROWARD COUNTY FOR FISCAL YEAR 2024-2025; AND PROVIDING FOR SEVERABILITY AND AN EFFECTIVE DATE.

WHEREAS, pursuant to the requirements of Section 200.065(2), Florida Statutes, the Board of County Commissioners of Broward County, Florida ("Board"), on September 17, 2024, held a public hearing on the final budget and final millage rate for the street lighting subdistrict in the unincorporated area of Broward County ("Street Lighting Subdistrict"); and

WHEREAS, the Board desires to adopt a final millage rate for Fiscal Year 2024-2025 for the Street Lighting Subdistrict, NOW, THEREFORE,

BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF BROWARD COUNTY, FLORIDA:

Section 1. The Board hereby adopts a final millage rate of 0.3743 for the Street Lighting Subdistrict in the unincorporated area of Broward County for the Fiscal Year beginning October 1, 2024, and ending September 30, 2025, which constitutes a 12.40 percent increase in property taxes, as compared to a rolled-back rate of 0.3330.

20           Section 2.    This Resolution shall be filed with the Broward County Finance and  
21   Administrative Services Department, Records, Taxes and Treasury Division, and a  
22   certified copy forwarded to the Broward County Property Appraiser, the Broward County  
23   Finance and Administrative Services Department, Records, Taxes and Treasury Division,  
24   and the State of Florida Department of Revenue.

25           Section 3.   Severability.

26           If any portion of this Resolution is determined by any court to be invalid, the invalid  
27   portion will be stricken, and such striking will not affect the validity of the remainder of this  
28   Resolution. If any court determines that this Resolution, in whole or in part, cannot be  
29   legally applied to any individual, group, entity, property, or circumstance, such  
30   determination will not affect the applicability of this Resolution to any other individual,  
31   group, entity, property, or circumstance.

32           Section 4.    Effective Date.

33           This Resolution is effective upon adoption.
