This inspection does not guarantee the condition of the inspected building or equipment; nor does it constitute a warranty of any electrical equipment or component and the applicant hereby agrees to hold Broward County Building Code and its employees harmless for any claim of liability or damages associated with the performance of the safety inspection. If discrepancies are found that require correction, an electrical permit will be required for said work.
