Hope Gary introduced herself, William Gary and the Fort Lauderdale Community Center (FLCC). Both provided background and overview of FLCC goals and objectives.

Ms. Gary announced that FLCC would not perform drug tests on applicants for the Employment Self-Sufficiency Program. Mr. Curry, CCCAB Chair, requested clarification and expressed concern that hiring without drug testing could enable drug users. Ms. Gary reiterated that FLCC would not advertise that drug tests are required and does not intend to administer drug tests to applicants or employees. Mr. Jefferson explained that as the contract administrator, he would confer with County Attorney's Office and respond to FLCC accordingly.
