1. <u>Second Reading of proposed amendments to Section F-121, Automatic External</u>
<u>Defibrillator (AED) and Bleeding Control Kit (BCK) of the Florida Fire Prevention Code, 7th
Edition (2020), recommendation of the Fire Code Committee</u>

a. Staff Report

Mr. Bryan Parks, Chief Fire Code Compliance Officer, advised that there is nothing to add from the first reading presentation. The effective date would be December 19, 2022.

b. Board Questions - none

Public Hearing

Mr. William Swartz advised that he is a resident of the Point of Americas Condominium and will be responsible for implementing these code changes. He was concerned about the equipment not being available on every floor. Because there is no personnel that could respond to such an emergency. He felt they would be better served with an emergency call system directly to the first responders. He hoped that the Board could assist with other ideas for larger buildings such as the Point of Americas.

Mr. Parks indicated that there is nothing to prevent a building from installing the equipment on every floor.

Chief Lori Hastings, representing the Broward Fire Chiefs Fire Prevention Sub-committee, advised that the code was liberalized to not require the equipment on every floor to reduce the financial impact. Dispatchers at the 911 emergency call center are fully capable of walking someone through operating a defibrillator, CPR, and the bleeding control. Additionally, dispatchers will be able to identify the AED locations. Buildings are not required to have trained personnel on-site because of the ease of using the equipment. The training was not built into the code amendment.

Chairman Lavrich noted that this proposal is a minimum requirement.

Chairman Lavrich noted on December 5, 2022, he received an email from Fred Nesbitt, President of Galt Mile Community Association, expressing support for this amendment, which he proceeded to read into the record. A copy of the email is attached to these minutes.

There being no one else wishing to speak, the public hearing was closed.

c. Board Action

Mr. Ulmer made a motion, and Mr. Falkanger seconded the motion to approve the amendment on the final reading as recommended. The motion was carried out by a unanimous vote of 12-0.

2. 2023 Board Nominations and Election of Officers

a. Staff Report

Dr. Ana Barbosa, Administrative Director, indicated that a review of the attendance record shows that everyone is eligible. She mentioned that Chairman Lavrich would be on a cruise for about four months but still available. Chairman Lavrich indicated he will be out of the country from January 5th to April 26th but will have internet access and is willing to serve

another term. Mr. Bailey explained that he is stepping down as a voting member because he is working more in Orlando now but would be willing to assume an alternate position.

Dr. Barbosa indicated that she has a list of individuals for the ad hoc committee regarding the physical presence of building officials and chief inspectors during regular business hours. She will be confirming their willingness to serve and plan for the first meeting by the end of January or the beginning of February. The Board will be kept apprised.

Reasons

With the approval of online notarization being adopted by BORA during November 10, 2022, meeting, the staff reviewed existing forms to ensure uniformity and ease for the applicant. The staff concluded that forms could be simplified with some changes.

Additional Information

The following revisions will simplify the application process for both the applicate and jurisdiction, having all the required information upfront and transparent so staff can process the applications promptly.

- 1. Add the online notarization checkboxes to the certification forms to meet the requirements of F.S.117.05 and remove the need for the additional jurat form. The proposed revision is compliant with Florida Statute 117.05.
- 2. Remove scrivener errors and unnecessary language and reformat forms, so they are more apparent to the applicate.
- 3. Add language to the fire forms, which were not present previously but now are in unison with code language.
- 4. Update the checklist on page two and add the language from BORA policy #18-02.

Any code professional (such as but not limited to engineers, architects or structural, plumbing, mechanical, or electrical contractors) who are required to hold or who otherwise holds a Certificate of Competency ("Certificate") or Professional License ("License") in any area of construction shall not use that Certificate or License to engage in free enterprise thereby competing against persons or firms whose work he may also inspect, nor may this individual allow their Certificate or License to be used by another person or firm.

Per Florida Statute 71-575 (4)b, commencing with the time of application submission, an applicant is prohibited from engaging in free enterprise including but not limited to bids, proposals, contracts, permits, etc. The applicant shall be required to provide a detailed list of all open and ongoing projects currently under construction which will include information such as the municipality they are located within, the existing permit number and the time frame in which the project will be completed. This time frame shall not exceed a 180 days period from the time the application for certification was submitted to BORA.

If this 180 days' time frame is required to be extended, a written request shall be submitted to the Director of the BORA no later than 30 days prior to the expiration of the 180 days period. This request for extension will be reviewed by the Board of Rules and Appeals ("Board") for approval at the next, upcoming meeting. An extension, if granted will be set by the Board depending on circumstances, unless the Board does not meet that month in which case the Administrative Director may extend the time frame until the next scheduled meeting. All extensions beyond this point shall follow the same notification rule as mentioned previously and shall be reviewed and voted on by the Board on a case by case basis.

If the candidate is still unsuccessful the candidate shall wait a mandatory period of no less than twelve (12) months from their last test before being able to retest.
- **F-103.6.4** Personnel assigned to the bureau as Fire Inspectors shall be State of Florida Certified Firefighters (see 18 month exception), State of Florida Certified Fire Inspectors. For certification refer to Florida State Statute 633. For certification refer to Florida State Statute 633. Individuals being considered for appointment will be required to complete an affidavit of compliance with 71-575 (see Board policy 14-02).

Exception: At Fire Chief's discretion, a person may be given up to eighteen (18) months to become a Florida Certified Firefighter, from the date of hire.

RE: First Reading of proposed modification to F-116.3.1 Exception, related to Airport FBOs and the fuel

storage above ground as recommended by the Fire Code Committee.

Recommendation

The Board of Rules and Appeals, Fire Code Committee, in a vote of 12 to 0, approved the modification to Section F-116.3.1 "Exceptions," wherein Airport Fixed Base Operations (FBOs) would be exempted from the provisions found in F-116.3.1 if they meet the requirements of NFPA 30 and have the support of the Airport Authority and acceptance after a review by the Fire Authority Having Jurisdiction (AHJ).

Reasons

The Board of Rules and Appeals staff received a request for a code modification as it pertains to F-116.3.1 from Mr. Alex Nomikos with Roundtable Technical Resources Inc., 1460 Breezy Way, Spring Hill Florida, who has been contracted to oversee a new FBO at Ft. Lauderdale Executive Airport (FXE). The new FBO, Atlantic Aviation, plans to develop a large parcel within FXE where they will offer aeronautical services, including but not limited to aircraft fueling, hangar storage, tiedown, and parking. In cooperation with FXE and with their approval, they will also support emergency operations by providing fuel to service both military and Broward Emergency Services when requested.

Additional Information

Proposed Change:

F-116.3 Aboveground Storage for Dispensing of Flammable and Combustible Liquids from UL listed 142 (double wall), 2085 or Equivalent Tanks:

F-116.3.1 Aboveground storage of flammable and combustible liquids shall be approved by the Fire Chief, Building Official, and/or their duly authorized representative after an appropriate review has been conducted. Such review includes, but is not limited to, an analysis of the proposed installation, location, distance separations, types of occupancies in the vicinity, tank corrosion protection and construction, and applicable zoning restrictions. The maximum storage capacity in any one location shall not exceed an aggregate total of 12,000 gallons. Aboveground storage of flammable and combustible liquids shall comply with the following regulations:

Exception: Municipal, county, and special districts, and airports (when approved by the Airport Aviation Authority, that the services of a Fixed Base Operation (FBO), supplying fuel to the general aviation community and emergency operations is needed) having aboveground fuel storage facilities shall comply with the provisions of NFPA 30. Aggregate Limitations of Flammable and Combustible Liquids as per F116.3.1 shall not apply. The permit shall be reviewed for compliance by the local Fire Service Provider/Fire Department AHJ.



SUBJECT: Board Policy #18-02 - Design Professional and Contractor requirements

to become a certified inspector, as it relates to the closing out of open

and ongoing projects.

POLICY:

This policy applies to all individuals that seek certification through Broward County Board of Rules and Appeals ("BORA") to be certified as a building code professional. Any code professional (such as but not limited to engineers, architects or structural, plumbing, mechanical, or electrical contractors) who are required to hold or who otherwise holds a Certificate of Competency ("Certificate") or Professional License ("License") in any area of construction shall not use that Certificate or License to engage in free enterprise thereby competing against persons or firms whose work he may also inspect, nor may this individual allow their Certificate or License to be used by another person or firm.

Per Florida Statute 71-575 (4)b, commencing with the time of application submission, an applicant is prohibited from engaging in free enterprise including but not limited to bids, proposals, contracts, permits, etc. The applicant shall be required to provide a detailed list of all open and ongoing projects currently under construction which will include information such as the municipality they are located within, the existing permit number and the time frame in which the project will be completed. This time frame shall not exceed a 180 days period from the time the application for certification was submitted to BORA.

If this 180 days' time frame is required to be extended, a written request shall be submitted to the Director of the BORA no later than 30 days prior to the expiration of the 180 days period. This request for extension will be reviewed by the Board of Rules and Appeals ("Board") for approval at the next, upcoming meeting. An extension, if granted will be set by the Board depending on circumstances, unless the Board does not meet that month in which case the Administrative Director may extend the time frame until the next scheduled meeting. All extensions beyond this point shall follow the same notification rule as mentioned previously and shall be reviewed and voted on by the Board on a case by case basis.

Florida Statute 71-575 (4)b

Any Inspector (such as and including but not limited to structural, engineering, plumbing, mechanical, or electrical) or other building official charged with enforcing or otherwise supervising or inspecting any work covered under any section of the South Florida Building Code as applicable to Broward County pursuant to Chapter 71-575, Laws or Florida, and who is required to hold or who otherwise holds a Certificate of Competency in any area of construction shall not use that Certificate of Competency to engage in free enterprise thereby competing against persons or firms whose work he may also inspect, nor may he allow his Certificate of Competency to be used by another person or firm.

RE: Rescind Formal Interpretation #23: Building Permit Valuation

Recommendation

That BORA rescinds by vote Formal Interpretation #23: Building Permit Valuation.

Reasons

This formal interpretation is now in conflict with both Florida Statute (FS) 553.79(f) and Broward County Amendments (Chapter 1) to Florida Building Code 2020, 7th Edition, section 109.3.1. Both, the FS and Chapter 1 prevent Building Officials from requiring a contract between a builder and an owner for the issuance of a building permit or as a requirement for the submission of a building permit application.

FBC 102.1 General

Where there is a conflict between a general requirement and a specific requirement, the specific requirement shall be applicable.

FBC 102.4.1 Conflicts

Where conflicts occur between provisions of this code and referenced codes and standards, the provisions of this code shall apply.

Florida Statute 553.79. (f) A local government may not require a contract between a builder and an owner for the issuance of a building permit or as a requirement for the submission of a building permit application.

FBC 109.3.1 The Building Official may require an estimate of the cost utilizing RSMeans, and/or other descriptive data as a basis for determining the permit fee. As mandated by HB-401-2021, a local government may not require a contract between a builder and an owner for the issuance of a building permit or as a requirement for the submission of a building permit application.

At its regularly scheduled meeting of September 10, 2020, the Broward County Board of Rules and Appeals approved an interpretation of the following sections of Chapter 1, "Broward County Amendments" to the 7th Edition (2020) Florida Building Code.

109.3 Building permit valuations. The applicant for a permit shall provide an estimated permit value at a time of application. Permit valuations, shall include total value of work, including materials and labor, for which the permit is being issued, such as electrical, gas, mechanical, plumbing equipment, and permanent systems. If, in the opinion of the building official, the valuation is underestimated on the application, the permit shall be denied, unless the applicant can show detailed estimates to meet the approval of the Building Official. Final building permit

109.3.1 The Building Official may require an estimate of the cost utilizing RS Means, copies of signed contract and/or other descriptive data as a basis for determining the permit fee.

Formal Interpretation:

The Broward County Board of Rules and Appeals interprets Sections 109.3 and 109.3.1 to state the Building Official must first determine a permit application is underestimated before the applicant can be required to provide a detailed validation of the valuation of the work to meet the approval of the Building Official. Therefore, the Building Official must have a reasonable basis for his or her determination that the valuation is underestimated and may not require a detailed estimate or contract attached to the permit application at the time of submittal.

Recommendation

That BORA adopts by vote, replacing BORA Policy 06-03, Minimum Requirements for Permanent Residential Type Stand-by Generators, with BORA Guideline 23-01 Minimum Code Requirements for Permanently Installed Residential Stand-by Generators.

Reasons

Policy 06-03 was created and adopted early in 2006, after Hurricane Wilma, when there was a rush to install permanent residential generators. Policy 06-03 is treated as de facto code by plans examiners and inspectors, but some of the prescriptive requirements in Policy 06-03 are not backed by code sections and are often the reason for challenges by consumers and contractors. Proposed Guideline 23-01 shows code sections and should be used by plans examiners and inspectors as a tool to make code references easier. An alternative version of Broward County Board of Rules and Appeals Guideline 23-01 with full code text is included for your consideration. BORA staff prefers the shorter version.

Additionally, the upcoming 2023 FBC Residential will have a section for permanently installed residential generators, which will make this guideline unnecessary.

MINIMUM CODE REQUIREMENTS FOR PERMANENTLY INSTALLED RESIDENTIAL STAND-BY GENERATORS

All code references are to the 2020 Florida Building Code, Residential, 7th Edition unless stated otherwise.

- 1. Location and clearances. See LOCATION G2406, G2408, M1307.1.
- 2. **Protection from floods.** See FLOOD-RESISTANT CONSTRUCTION R322.1.6, M1301.1.1. Protection of mechanical, plumbing, and electrical systems, or R322.1.1 Alternative provisions (ASCE-24-2014).
- 3. Wind resistance. See Wind resistance G2404.6, M1307, M1301.1.
- 4. **Generator exhaust.** See BORA's Formal Interpretation # 26, "Location of permanently installed residential standby generator's exhaust".
- 5. Listing and labeling. See Listed and labeled. G2404.3, M1302.1.
- 6. **Electrical installation**. See Electrical G2410, M1307.5.
- 7. **Piping.** G2413, G2414, G24115.
- 8. **Other codes.** When applicable, the following Codes and Standards shall apply: 2020 Florida Fuel Gas Code 7th Edition; 2020 Florida Building Code, Mechanical, 7th Edition; NFPA 58-14 Liquefied Petroleum Gas Code, NFPA 37-18 Stationary Combustion Engines and Gas Turbines, NFPA 30-18 Flammable and Combustible Liquids Code, and the.
- 9. **Zoning**. Maximum allowable sound levels and property setbacks shall comply with local jurisdiction's zoning requirements.

MINIMUM CODE REQUIREMENTS FOR PERMANENT RESIDENTIAL TYPE STAND-BY GENERATORS

- Generators (Engines) shall be installed at least 5 feet from structures having combustible walls unless there is an adjacent wall that has a fire resistance rating of at least 1 hour between the structure and generator.
- The generator shall be installed in compliance with floodplain management construction standards (same elevation above grade as the interior 1st floor of the building).
- Generators that are exposed to wind shall be installed to resist the wind pressures according to ASCE (American Society of Civil Engineers) 7 –2007.
- Generators installed at grade level shall be supported on a level minimum 4 inch nominal (3.5 inch actual) concrete slab or other approved material extending a minimum of 2 inches above adjoining finished grade. Such slabs shall be placed on clean, thoroughly compacted sand or crushed rock free from organics, debris or other deleterious materials.
- Generator exhaust shall be located so as not to create a nuisance. Exhaust termination shall be a minimum of 10 feet from any openable openings (doors, windows, vents, etc.) or air intakes.

Exception: Where a Carbon monoxide (CO) alarm(s) is installed in the residency in accordance with Section R315.1.1 CARBON MONOXIDE ALARMS of the 2017 Florida Building Code - Residential, Sixth Edition, or the alarm's manufacturer installation requirements and listing, whichever is more restrictive; the generator exhaust can be located in compliance with Section M1804.2.6 Mechanical draft systems of the 2017 Florida Building Code - Residential, Sixth Edition or with generator manufacturer installation requirements and listing, whichever is more restrictive.

- Generators shall be listed and labeled. Generators shall be installed according to the manufacturer's recommendations and by the terms of their approval, in accordance with the conditions of the listing. Where conflicts between 1) the code, 2) the conditions of listing or, 3) the manufacturer's installation recommendations occur, the most restrictive of the three alternatives shall apply.
- When applicable, the following Codes and Standards shall apply: 2017 Florida Building Code -Residential, Sixth Edition, NFPA 58-14 - Liquefied Petroleum Gas Code, NFPA 37-15 - Stationary Combustion Engines and Gas Turbines, NFPA 30-15 - Flammable and Combustible Liquids Code, ANSI/ASME B31.3-2012 Process Piping, and the 2017 Florida Fuel Gas Code 6th Edition.
- 8. Installations shall comply with the Florida Fire Prevention Code
- Maximum allowable sound levels and property setbacks shall comply with local jurisdiction's zoning requirements.
- Electrical installation shall comply with NFPA 70-2014 National Electrical Code.

DRAFT ALTERNATIVE VERSION

Broward County Board of Rules and Appeals Guideline 23-01

MINIMUM CODE REQUIREMENTS FOR PERMANENT RESIDENTIAL TYPE STAND-BY GENERATORS

All code references are to the 2020 Florida Building Code, Residential, 7th Edition unless stated otherwise.

1. Location and clearances. LOCATION G2408.1 (305.1) General.

Equipment and appliances shall be installed as required by the terms of their approval, in accordance with the conditions of listing, the manufacturer's instructions and this code. Manufacturer's installation instructions shall be available on the job site at the time of inspection. Where a code provision is less restrictive than the conditions of the listing of the equipment or appliance or the manufacturer's installation instructions, the conditions of the listing and the manufacturer's installation instructions shall apply.

Unlisted *appliances approved* in accordance with Section G2404.3 shall be limited to uses recommended by the manufacturer and shall be installed in accordance with the manufacturer's instructions, the provisions of this code and the requirements determined by the *code official*.

2. Protection from floods. FLOOD-RESISTANT CONSTRUCTION R322.1.6 Protection of mechanical, plumbing and electrical systems.

Electrical systems, equipment and components; heating, ventilating, air conditioning; plumbing appliances and plumbing fixtures; duct systems; and other service equipment shall be located at or above the elevation required in Section R322.2 or R322.3. If replaced as part of a substantial improvement, electrical systems, equipment and components; heating, ventilating, air conditioning and plumbing appliances and plumbing fixtures; duct systems; and other service equipment shall meet the requirements of this section. Systems, fixtures, and equipment and components shall not be mounted on or penetrate through walls intended to break away under flood loads.

Exception: Locating electrical systems, equipment and components; heating, ventilating, air conditioning; plumbing appliances and plumbing fixtures; duct systems; and other service equipment is permitted below the elevation required in Section R322.2 or R322.3 provided that they are designed and installed to prevent water from entering or accumulating within the components and to resist hydrostatic and hydrodynamic loads and stresses, including the effects of buoyancy, during the occurrence of flooding to the design flood elevation in accordance with ASCE 24. Equipment for pools, spas and water features shall be permitted below the elevation required in Section R322.2 or R322.3 provided it is elevated to the extent practical, is anchored to prevent flotation and resist flood forces, and is supplied by branch circuits that have ground-fault circuit-interrupter protection. Electrical wiring systems are permitted to be located below the required elevation provided that they conform to the provisions of the electrical part of this code for wet locations.

3. Wind resistance. G2404.6 (301.10)

Appliances and supports that are exposed to wind shall be designed and installed to resist the wind pressures determined in accordance with this code.

4. Generator exhaust. See BORA's Formal Interpretation # 26. Generator exhaust shall be located so as not to create a nuisance. Exhaust termination shall be a minimum of 10 feet from any openable openings (doors, windows, vents, etc.) or air intakes.

Exception: Where a Carbon monoxide (CO) alarm(s) is installed in the residency in accordance with Section R315.1.1 CARBON MONOXIDE ALARMS of the Florida Building Code - Residential, Sixth Edition, or the alarm's manufacturer installation requirements and listing, whichever is more restrictive; the generator exhaust can be located in compliance with Section M1804.2.6 Mechanical draft systems of the Florida Building Code - Residential, Sixth Edition or with generator manufacturer installation requirements and listing, whichever is more restrictive.

5. Listed and labeled. G2404.3 (301.3)

Appliances regulated by this code shall be listed and labeled for the application in which they are used unless otherwise approved in accordance with Section 104.11 of the Florida Building Code, Building. The approval of unlisted appliances in accordance with Section 104.11 of the Florida Building Code, Building shall be based upon approved engineering evaluation.

6. ELECTRICAL

SECTIONG2410 (309)

G2410.1 (309.1) Grounding.

Gas piping shall not be used as a grounding electrode.

G2410.2 (309.2) Connections.

Electrical connections between appliances and the building wiring, including the grounding of the appliances, shall conform to Chapter 34. (Electrical installation shall comply with NFPA 70-2014 National Electrical Code.)

- **7. Piping**. G2413, G2414, G24115.
- **8. Other codes.** When applicable, the following Codes and Standards shall apply: NFPA 58-14 Liquefied Petroleum Gas Code, NFPA 37-15 Stationary Combustion Engines and Gas Turbines, NFPA 30-15 Flammable and Combustible Liquids Code, ANSI/ASME B31.3-2012 Process Piping, and the 2017 Florida Fuel Gas Code 6th Edition.
- **9. Zoning.** Maximum allowable sound levels and property setbacks shall comply with local jurisdiction's zoning requirements.
