## Frequently Asked Questions – Special Event (Super Bowl) Permits

- 1) How much will a Special Event permit cost?
  - \$100 per vehicle
- 2) How long will the Special Event permit be valid for?
  - The temporary permit will be valid for two (2) weeks, January 26, 2020 thru February 9, 2020.
- 3) Where would I purchase the Special Event permit?
  - The permit can be purchased from the office that issued your annual operating permits. If you have annual operating permits from Broward, Palm Beach, and Miami Dade Counties, you can purchase the Special Event permit at any of the locations.
- 4) What types of vehicles can obtain the Special Event permit?
  - Luxury sedans, stretch limousines, and transport vans will be able to apply for the Special Event permit. Special Event permits will not be issued to taxis.
- 5) Will I need a separate Special Event permit for each of the counties?
  - No, the permit will be valid for operating within Broward, Palm Beach, and Miami Dade Counties to include Fort Lauderdale International Airport (FLL), Palm Beach International Airport and Miami International Airport. Passengers may be picked up or dropped off in any of the three (3) counties.
- 6) I currently possess annual operating permits in one of the three (3) counties; will I be able to operate in all three (3) counties without purchasing an additional permit?
  - Yes, during the two (2) week period, you will be able to pick up and drop off, in Broward, Palm Beach, and Miami Dade Counties if the vehicle displays a valid operating permit issued from Broward, Palm Beach, or Miami Dade County.
- 7) Can a permitted company add vehicles to their fleet during this time?
  - Yes, vehicles can be added to an existing fleet by purchasing Special Event permits for the additional vehicles.
- 8) Will other temporary or replacement permits have the same reciprocity throughout the counties?
  - No, only vehicles with a valid Broward, Palm Beach, or Miami Dade operating annual permit or the Special Event Temporary permit will be able to take advantage of the reciprocity agreement. Other temporary permits are not included.
- 9) What, if any, requirements would there be for the drivers?
  - Drivers must possess a valid chauffeur's registration issued by Broward, Palm Beach, or Miami Dade County or be certified by the company issued the permit(s), such certification stating that drivers meet the requirements outlined in the permitting County's VFH Ordinance.

- 10) Will there be any location(s) that I will not be able to pick up passengers with the Special Event permit?
  - Yes, you will not be able to pick up passengers at Port Everglades, Port of Palm Beach, or Port of Miami.
- 11) Do I need to be a licensed Vehicle for Hire Business in Broward, Palm Beach, or Miami Dade County to be eligible for a Special Event permit?
  - Yes.
- 12) What documentation do I need to apply for a Special Event permit?
  - This will depend on the County issuing the permit. Each County's requirements are summarized at TriCountyVFH.org.
- 13) How can I obtain a Tri-County Special Temporary Permit(s) if I am not currently permitted in one of the three counties?
  - There are two options:
    - Obtain a regular permit from one of the three counties and obtain the Tri-County Special Temporary Permit(s) under that regular permit. The permitting process varies by county; the time to acquire a regular permit is measured in weeks. Interested parties are therefore encouraged to begin this process immediately by contacting one of the <u>Primary Contacts</u> and inquiring about the process.
    - Partner with a permitted company and obtain a Tri-County Special Temporary Permit(s) for your vehicle(s) under that company's permit. Under this scenario, the Tri-County Special Temporary Permit(s) can be issued in days.
