Broward County Towing Industry Fee Adjustments for Fiscal Year 2020

Per Sections 40.50 and 27.150(f)(6) of the Broward County Administrative Code, towing industry fees are to be reviewed annually and increased by the annual percentage increase in the Consumer Price Index or 3%, whichever is less. The 2018 to 2019 annual CPI increase was 3.0% as determined by the Environmental and Consumer Protection Division after review of the Bureau of Labor Statistics, Southeastern Regional Office CPI data. Accordingly, towing industry fees for 2020, increased by 3.0%, are reflected below and are effective October 1, 2019. Please contact Broward County at 954-519-1260 with any questions or concerns.

Towing and Immobilization Fees. The Broward County Board of County Commissioners hereby determines, establishes, and fixes the following fees:

- (d) Expedited Fee..... \$244.72
- (e) Annual Storage Site Inspection Fee..... \$108.76
- (f) Storage Site Reinspection Fee..... \$54.38
- (g) Criminal Background Check(s). Applicant shall pay all fees charged by the Florida Department of Law Enforcement to secure the necessary criminal history and records report(s), including out of state reports for applicants who have resided in Florida for fewer than five (5) consecutive years immediately preceding the date of application.
