**Conditions of Division Lease Approval**

- The Owner (Lessor) of the Broward County Certificate of Public Convenience and Necessity (the Certificate) listed above is leasing the permit associated with this Certificate.
- The Lessor authorizes the Broward County Environmental and Consumer Protection Division (the Division) to inspect and issue a permit to the Lessee, and to continue to issue renewal permits to the Lessee until the Lessor notifies the Division in writing that the lease arrangement has been terminated.
- The Lessor agrees that should the lease arrangement terminate prior to the annual expiration of a permit, that it shall be the responsibility of the Lessor to return the physical permit to the Division.
- The Lessor agrees to assist the Division in any reasonable manner necessary to ensure that Lessee complies with Chapter 22 ½ of the Broward County Code of Ordinances (the Motor Carriers Ordinance).
- The Lessor understands that he/she may be held responsible for violations of the Motor Carriers Ordinance, committed by the Lessee while operating under a valid permit associated with the Certificate.
- The Lessor understands that if the Certificate (and associated permit) remains unused during any consecutive ninety (90) day period it will be deemed abandoned, subject to provisions of Section 22 ½ -5 of the Motor Carriers Ordinance.
- The Lessor understands that the Certificate may be subject to suspension, revocation, and/or forfeiture proceedings under Section 22 ½-13 of the Motor Carriers Ordinance as a result of the conduct of the Lessee.
