**SUBJECT:** Five Day Notice – CBE Goal Waiver or Less Than 25% CBE Goal (September and October 2025)

On December 10, 2024, the County Commission approved agenda item #84 amending various sections of Chapter 1 of the Broward County Code of Ordinances, which requires notice to the Board of CBE goals that are waived or modified.

In compliance with Section 1-81.3(c), a CBE goal may be waived or modified upon written recommendation by OESBD, if no County Commissioner objects within five (5) business days after receiving written notice from the OESBD. If a County Commissioner timely objects to the proposed CBE goal waiver or modification, an agenda item will be prepared for Board approval of the CBE goal waiver or a CBE goal set less than 25% for a project.

Therefore, please find OESBD's recommendations for the proposed CBE goal waivers or modifications (less than 25%), with their respective determinations, for reviews completed in the months of September and October.
