Attached is a letter from Bold Justice thanking us for the past tree giveaways and requesting three more. This email is to officially request funding support from the Tree Preservation Trust fund.

We have the suggested location for a first tree giveaway. Dates and further locations would be set once funding is approved. As in the past, the NatureScape schedule would mean that we might have one in December, maybe January, and most likely the third would be in May. NatureScape has Emerald Awards in February/March, Water Matters Day in March and Earth Month in April.

Once funding is approved and locations and dates are agreed upon, I will create flyer's as in the past. Featuring the 2 fruit varieties and 2 shade tree varieties being offered.
