CERTIFICATION OF COMPLETION OF CONSTRUCTION PROCEDURE

- DEP Form #62-604.300(8)(b), Request for Approval to Place a Domestic Wastewater Collection/Transmission System Into Operation. Any deviation to the original construction design must be noted under item (4) Page 3 of 3.
 - Broward County EEPD Page 4 Addendum to the above form (this form).
 - Gravity Sewer: information submitted should include, but is not limited to: lamping reports, leakage tests, etc.
 - Lift Station: information submitted should include, but is not limited to: One (1) example of the lift station equipment manual, pressure tests, lift station start-up reports, signage photo, copy of contracts, etc.
 - 8.5" x 11" as-built site plan. Minimum: must contain streets and foot prints of buildings. Send EEPD an email with the attached PDF of the site with gravity and lift station location on one page. You may email this site plan at time of submittal. Reference our license number and include the term "Site Plan" in the subject line. Questions and site plans should be directed to WWLicense@broward.org.
- One (1) set of as-built or record drawings submitted with all pertinent pages for approval, signed and sealed by the Engineer of Record. EEPD may field inspect projects prior to certification for compliance to standards. Therefore, these documents should be submitted prior to covering trenches. However, if paving of roads, pouring of sidewalks, planting and landscaping, etc., are done prior to EEPD's as-built approval, it shall not relieve the licensee from the responsibility for making any corrections to the sanitary sewer system as may be required by the County.
- The current EEPD Record Drawing Review Fee of \$100.00 must be submitted payable to the Broward County Board of County Commissioners.
