The portfolio of Broward County shall be limited to the eligible securities pursuant to the provisions of the Broward County Administrative Code, Section 22.83, entitled "Eligible Securities", a copy of which is attached hereto and made a part hereof as Exhibit "1", or any additions by ordinances enacted by the Broward County Board of County Commissioners. Investments in any derivative securities, including interest only or principal only, inverse floaters investments, and short sells are prohibited unless specifically designated therein.

**AUTHORIZED PERSONS:**
