**1. Provide a description that addresses the entire scope of the proposed project.**

The NewHart project is a 36-bed supportive permanent housing program for persons experiencing homelessness with disabling conditions such as substance use disorders, mental illness, HIV/AIDS, who are at increased risk for returning to homelessness. Housing participants may be veterans ineligible for Veteran's Supportive Housing (VASH) vouchers and/or older adults. The target population to be served as housing slots are vacated are chronic homeless individuals with disabilities and co-occurring disorders who have been identified by the Broward County CoC Coordinated Assessment & Housing Placement process as most in need of PSH assistance. The Newhart project follows a housing first program model with scattered site housing.

Challenges to housing include substance use and relapse, mental health disorders, criminal background history, health complications and extended unemployment related to these barriers. The project provides permanent supportive housing, case management and linkage and referral to a range of supportive services. Through cost savings it is expected that additional clients will be served. Over a 12-month period the program will serve 36 to 38 individuals, mostly non-veteran and 4-6% may be victims of domestic violence. DV clients will be served with a trauma informed approach and provided access to victim services and therapy. Over 50% of the population will have co-occurring mental health disorders, over 50% will have physical health problems and most will have a disabling Substance Use Disorder. It is the goal of the program for 75% of the individuals served to remain in permanent housing or exit to permanent housing in the operating year. It is then estimated that 80% that exit the program will not return to homelessness within 6 months. Focus will be on increasing self-sufficiency and self-determination through vocational rehabilitation, education and training and referrals for budgeting and credit repair. It is the goal of the project that 45% of individuals will maintain or increase their total income from all sources as a result of these interventions. The project currently uses Service Point for its HMIS except when serving DV clients and has a current CHO End User Agreement with the HMIS Lead. HMIS compliance with System Performance Measures is monitored with ongoing quality assurance oversight. The performance improvement plan includes monitoring for timely submission of data in the Entry/Exit area at the time of new participant admissions into housing and increasing income. The project subrecipient has extensive experience managing CoC & other federal grants.
