Revised policy and procedure coupled with improvements in the Enterprise Resource Planning system implemented at the beginning of County fiscal 2017-18 have resulted in an 18% improvement in project drawdowns from FY2016. These implementations will assist in ensuring 100% quarterly drawdowns for all programs moving forward.

### 3B. Project Description

**1. Provide a description that addresses the entire scope of the proposed project.**

The HART & Home project is a 26-bed permanent supportive housing program that addresses the needs of chronically homeless individuals with disabling conditions of substance use disorders and co-occurring disorders. Co-occurring disorders such as mental illness, HIV/AIDS, or other disabilities, along with substance use present severe barriers to housing stability. Participants may also be veterans and/or older adults. All participants will be 18 years of age and up. The project provides intensive case management, utilizing the techniques of motivational interviewing, harm reduction, and trauma informed care as strategies to promote healthy lifestyles. Rental Assistance funds are utilized to access permanent safe housing through scattered-site apartments leased from local landlords. The program assists with linkage to vocational rehabilitation and substance use detoxification and treatment services. Referrals are received through the Broward County CoC Coordinated Assessment & Housing Placement System. The project uses SevicePoint for its HMIS except when serving DV clients and has a current CHO End User Agreement with the HMIS Lead. HMIS system outcomes are monitored for compliance no less than monthly and ongoing performance improvement efforts and quality assurance oversight is provided. This project supports individuals in their recovery process promoting harm reduction, self help, treatment and community involvement. Through the linkage, follow-up, and monitoring of identified necessary resources, staff involved in this project help by removing barriers to ongoing stability. Through the use of cost savings it is expected that additional clients may be served dependent on rent reasonableness and the current FMR. Over a 12-month period the program will serve approximately 28 chronic homeless individuals, primarily non-veteran along with 4 or more victims of DV. DV survivors will be supported with a trauma informed approach and will be assisted with linkage to victim services and therapy options. The HART & Home project follows a housing first program model. Over 50% of the population will have co-occurring mental health disorders, and over 50% will have physical health problems. The complexity of their needs coupled with felony criminal backgrounds present multiple challenges to stability. CoC funds are essential in providing needed funds to maintain housing stability. Efforts will be focused on increasing self-determination and self-sufficiency with job skills training along with budgeting and credit repair programs. It is the goal of the program for 75% of the individuals served to remain in permanent housing for a minimum of 6 months and 75% to remain in permanent housing at the end of the operating year. It is then estimated that 80% will exit to permanent housing and will not return to homelessness within 12 months. The program will expect 45% to maintain or increase income through the operating year.




