3B. Project Description

1. Provide a description that addresses the entire scope of the proposed project.

The HART & Home project is a 26-bed permanent supportive housing program that addresses the needs of chronically homeless individuals with a disabling substance use disorder and co-occurring disorders who have several risk factors for continued substance use involvement and homelessness. Individuals who receive services through this project may have co-occurring disorders such as mental illness, HIV/AIDS, or other disabilities. They may also be veterans and/or older adults. All of the individuals served will be 18 years of age and up. This project provides intensive case management, referral for vocational rehabilitation and substance abuse treatment, coupled with permanent housing to participants, while utilizing the techniques of motivational interviewing, harm reduction, and trauma informed care as strategies to promote healthy lifestyles. Rental Assistance funds are utilized to access permanent safe housing through scattered-site apartments leased from various local landlords. The program also provides case management and linkage and referral to a range of supportive services. Referrals to the project are received through the Broward County Continuum of Care's Coordinated Assessment & Housing Placement System. The project currently uses SevicePoint for its HMIS except when serving DV clients and has a current CHO End User Agreement with the HMIS Lead. This project targets support to individuals in their recovery process promoting harm reduction, self help, treatment and community involvement. Through the linkage, follow-up, and monitoring of identified necessary resources, staff involved in this project help persons in their recovery efforts to become selfsufficient

and substance free. Through the use of cost savings it is expected that additional clients may be served dependent on rent reasonableness determinations and the current rental housing market. Over a 12-month period the program will serve approximately 28 chronic homeless individuals, primarily non-veteran along with 2 to 4 victims of domestic violence. The HART & Home project follows a housing first program model.

Over 50% of the population will have co-occurring mental health disorders, and over 50% will have physical health problems. The complexity of their needs coupled with a history of felony criminal backgrounds present multiple challenges to housing stability and self-sufficiency. It is the goal of the program for 80% of the individuals served will remain in permanent housing for a minimum of 6 months and 80% to remain in permanent housing at the end of the operating year. It is then estimated that 80% will exit to permanent housing and will not return to homelessness within 12 months. The program will expect 45% to maintain or increase income. The project recipient Broward County has extensive experience managing CoC and other federal grants.
