

Rights of Passage (ROP) is a transitional housing program serving homeless 14 male and female youth under the age of 21. The population served includes pregnant/parenting teens and their children. Participants reside in scattered-site apartments in Broward County. The applicant, Covenant House Florida (CHF) conducts street outreach at multiple locations throughout the county and participates in the COC. As part of a coordinated service system CHF provides comprehensive services to youth including: basic necessities, referrals, and transportation to CHF's Emergency Shelter (open 24 hours a day, 7 days a week). Homeless youth also learn about CHF from school staff, other homeless youth, police officers, and homeless helplines.

CHF emergency shelter participants spend their first 7-10 days completing a battery of assessments designed to identify each youth's strengths and risks related to their physical, emotional, behavioral, educational, employment, and social well-being. At completion youth meet with trained Clinical Specialists to develop an Individualized Strength Based Action Plan identifying services to address the participant's needs/barriers to success. CHF provides on-site: substance abuse treatment, individual/group/family therapy, GED, and employment assistance/job placement. CHF works with BCPs and local educational institutions to assist youth with academic education. Youth who could benefit from transitional housing are assisted to enter ROP, obtaining furniture/household items, and moving to a scattered site shared 2-bedroom apt. ROP CMs assist youth to remove barriers and develop new goals leading to increased income, skills and self-determination enabling youth to attain self-sufficiency in stable permanent housing within 24 months. CHF pre-identifies affordable units in compliance with HUD rent reasonableness and HQS requirements. Units are screened to insure they are close to employment, transportation and other amenities. While in the apts. staff meet w/youth a minimum of 3x weekly, including at least 1 face-to-face and weekly home visits to assist with life skills, money management/consumer awareness, food management, health, housekeeping, transportation, education planning, job seeking/maintenance, emergency & safety skills, knowledge of community resources, interpersonal skills, legal skills, & housing. CHF provides 12 months follow-up/aftercare.

ROP has maintained positive outcomes. Project goals for 2022: (1) housing retention, 64% will exit to permanent housing destinations; (2) Self-sufficiency, 71% of youth will increase total income (From all sources) from CHF admission to program completion; and (3) return to homelessness, 80% of youth exiting to permanent housing will not become homeless for 6 months. Effective use of

data is essential in driving project goals and services. The project currently uses Service Point for its HMIS its clients and has a current CHO End User Agreement with the HMIS Lead Agency.







I. POLICY

It is the policy of Covenant House Florida (CHF) to comply with the requirements of the Code of Federal Regulations, Title 24 (Department of Housing and Urban Development), Part 84, Section 42, regarding Codes of Conduct.

II. PURPOSE

To maintain written standards of conduct governing the performance of CHF employees, officers, directors, or legal counsel, in the award and administration of contracts or agreements supported by Federal HUD funds.

To avoid any real or apparent conflict of interest.

III. PROCEDURE

- A. Code of Conduct: CHF's procurement practices shall be governed by its Code of Conduct (Attachment A) which applies to all personnel, employees, volunteers, directors, officers or any person acting in any capacity for CHF, particularly with regard to any aspect of procurement with Federal HUD funds
- B. Conflict of Interest: CHF will avoid any real or apparent conflict of interest (see Personnel Policies & Procedures Manual/#F-7), particularly in the use of Federal HUD funds, and ensure full disclosure as follows:
1. On an annual basis every member of the Board of Directors, Legal Counsel, and executive and selected staff members of CHF complete a Conflict of Interest Questionnaire regarding their relationship, if any, with CHF vendors.
  2. Relationships with vendors, if any, are disclosed to the Board of Directors at their first meeting of the fiscal year for review.
  3. An annual conflict of interest disclosure, reflecting the results of this evaluation, is reviewed and approved by the Board of Directors and appropriately disclosed.

3. CHF's employees, officers, directors, or volunteers shall neither solicit nor accept gratuities, gifts, consulting fees, trips, favors or anything having a monetary value in excess of ten dollars (\$10.00) from a vendor, potential vendor, or from the family or employees of a vendor, potential vendor or bidder; or from any party to a sub-agreement or ancillary contract. Examples of an acceptable gift could be; food product samples (may exceed \$10 value) when used to the benefit of CHF's clients or students; or a personal gift or meal valued at \$10.00 or less which is not intended to influence a procurement award, decision or enforcement action.
4. As permitted by law, rule, policy or regulation, CHF shall pursue appropriate legal, administrative or disciplinary action against an employee, officer, director, volunteer, vendor or vendor's agent who is alleged to have committed, has been convicted of or pled no contest to a procurement related infraction. If said person has been convicted, disciplined or pled no contest to a procurement violation, said person will be removed from any further responsibility or involvement with grants management, procurement actions or bids, consistent with CHF's policy, State Rule or Law, Federal Rule, Policy, Guidance or Law.
