**AGENDA ITEM 6 - STATUS UPDATE**

**A. JAIL POPULATION MANAGEMENT DASHBOARD - PHASE 1 AND II - DARREN SIEGER, CLASSIFICATION MANAGER, BSO**

CHAIR SPATH: Status update, jail population management dashboard, Darren Sieger.

MR. SIEGER: Okay. Good afternoon, everybody. Happy to report our connectivity issues with our Phase 1 of the dashboard has been rectified. I want to thank Adam and the Public Defender's Office for helping us with testing, and Mr. Jefferson's office. We're back online.

I need to touch base with a couple of users, the State Attorney's Office and the Clerk's Office and Judge Tuter, just to make sure that they're fully connected. So that's good. And Phase 2, we're still in testing of our Phase 2 of the dashboard.

**A. REPORT - CURRENT JAIL POPULATION, ALPHONSO JEFFERSON, JR., ASSISTANT COUNTY ADMINISTRATOR**

CHAIR SPATH: Reports. Current jail population, Alphonso Jefferson.

MR. JEFFERSON: For this advisory board, I did send out a couple of slides on the jail population. I apologize, that's all I could do today, because I'm dealing with other stuff right now. So I will definitely have that after this meeting. I will send all the reports out to you. Actually, reports are actually coming directly from the jail population dashboard, so hopefully, when many of you get access to it, a lot of that information will just be readily at your -- at your disposal. And maybe if Darren, hopefully, at the next meeting, maybe we can just bring it back up, because we're making a lot of changes to it. Maybe we can bring it back up so that the entire advisory board can see the entire dashboard.

MR. SIEGER: Sure. We can do a short, like a five-minute demo.

MR. JEFFERSON: Okay.

### **B. 750 REPORT - DARREN SIEGER, CLASSIFICATION MANAGER, BSO**

CHAIR SPATH: 750-day report, Darren Sieger.

MR. SIEGER: Good afternoon again, everybody. We track -- for you that are new to the meeting, we do track inmates that are unsentenced 750 days or longer. You should have a packet in front of you. Last month we had -- flip to the first graph -- last month, we had 239 inmates on the list.

Just to show movement, 16 inmates were removed from the list last month, meaning their cases were resolved. However, 13 new cases were added to the list. So we went from 239 to 236.

The second graph tracks how many total incarceration days all the inmates total up to. So we're up to 284,886 incarceration days. And then behind that graph is the list of inmates pretty much set up in a way that it lists the individual, their most serious offense that they're in custody on, how long they've been in custody, and some of the judicial information related to their case. That's all I have, Mr. Chair.

### **C. REPORTS ON CIVIL CITATION AND JUVENILE PREDISPOSITION SERVICES PROGRAM - TAMICA GAYNOR, ADMINISTRATOR BROWARD COUNTY HUMAN SERVICE DEPARTMENT**

CHAIR SPATH: Reports on civil citation and juvenile predisposition services, Tamika Gaynor.

MS. GAYNOR: Yes, Tamika Gaynor, Justice Services. For juvenile civil citation last month, we had 66 new referrals. We had 41 children discharged and 37 of which were successful. For JPS we had 14 enrolled, and two discharges. Both were successful.

MS. SCHNEIDER: Our numbers are pretty steady. You know, they've steadily been decreasing in terms of cases coming in. We have increased our number of referrals to both the PTI and to mental health diversion programs. They have slowly been increasing. And we're holding steady just about everywhere else.

### **D. PUBLIC DEFENDER**

CHAIR SPATH: Public Defender.

MR. GOLDBERG: I've got nothing to report. I just wanted to let everyone know, in the new year, you can expect an email from us to the various stakeholders. We've got some concerns about some technology issues that I think affect all of our offices, so we'd like to set a meeting with the different stakeholders talking about data sharing and a couple of other issues. So just look forward to speaking with you next year.

## **E. BSO DETENTION**

CHAIR SPATH: All right. I was advised that Colonel Reyes is not going to be here for the BSO detention.

## **F. BSO DEPARTMENT OF COMMUNITY PROGRAMS**

CHAIR SPATH: BSO Department of Community Programs, Dave Scharf.

MR. SCHARF: Just a couple of -- couple of things. Tamika, in regards to the juveniles, we have been part of the Governor's Executive Order Task Force, reference to the Marjory Stoneman Douglas Act. And we are, as a group -- there's a bunch of people who are working on trying to identify and earmark some triggers as a result of the many incidents we've had in the last couple of months, threats at school. So that's moving forward well. It's been a -- it's been a good exercise so far.

We were talking earlier about the Community Response Team. I just want to bring you guys up to date in regards to the opioid epidemic. We're down to about 1.5 deaths per day. We were at five about this time last year. Part of the -- part of the success of this has been this Community Response Team's comprehensive approach to the issue. Our latest -- to update you on our latest initiative, Broward Health, which encompasses Broward General and North Broward, two of the biggest hospitals in the County, have agreed to get on board with a peer specialist program.

So if someone's brought in to one of those major hospitals suffering from an overdose, non-fatal, what's happening is peer specialists, in conjunction with Henderson Behavioral Health and a couple other people, are dispatched to that hospital to greet and meet with that patient in hopes of reducing the overdose rate. We were seeing a tremendous amount of repeat overdoses, and we're going to be tracking that right now, now that we have this program. We did a pilot project with Holy Cross Hospital that was successful. So hopefully this final initiative will have some impact on the amount of overdoses that we are experiencing.

I will tell you that the drug flakka, Alpha-PVP, is back on the streets of Broward County. We're going to see more cases of that. We're seeing some of the synthetic marijuana K2 with spice being spiked with what are called cathinones. That's a -- those are the -- the drugs that are -- are found in flakka and some of the others. (Inaudible) and all that stuff. But expect that to make a comeback in the very near future because of the price of it. So we'll be seeing some of that. Other than that, that's it.

## **I. BROWARD POLICE CHIEF'S ASSOCIATION**

CHAIR SPATH: Broward County Police Chief's Association?

CHIEF MAGLIONE: Rick Maglione from the Broward Chiefs. I don't have a report update other than their stance on the adult civil citation, which I know we're not quite ready to roll it out, but you just have mixed reviews from it. There's about half the agencies that support it fully, like Fort Lauderdale. You have some that already have their own type of program and are hesitant to switch over. And there's others that do not support it. That's why there hasn't been a letter of support or any type of organization support, in general, for the program. But the agencies that don't support it know it's a tool that's available. They can use it if they want to when it's -- or not.

And I've also emphasized to them, you know, this is what's available, but your policy and your directives on how to use it can be more restrictive. If you don't agree with certain things as qualifying offenses, then eliminate those qualifying offenses in your policy, and then you still have that tool to use. So lukewarm response to it, but I think you're going to see at least a majority of the agencies use it in some form or fashion.

I think one of the biggest sticking points is, you know, they're looking at it like juvenile civil citation, where it's going to prevent someone from being entered into the criminal justice system. And I think some of the issues that some of the agencies had was you just don't have to have a felony in three years. And they feel that wasn't the purpose of this. It would be more for the person who makes a mistake, minor offense, and doesn't have to be entered at all, as opposed to someone who already has maybe an extensive criminal record. Why go back into the citation program if they've already established a criminal record?

You know, and I said, listen, don't look at it that way. What about the 18-year-old or 19-year-old who gets caught with a beer or some marijuana? It's more for that than the 40-year-old who did 30 years in prison in three different stints. This isn't really to benefit them. So I think they're coming around, but we'll see when it -- when it rolls out. But I don't think you're going to see the, you know, unified support like you have with the juvenile civil citation.

CHAIR SPATH: I have one question I'd like to ask. How can you track it? Is there a

way that you could track it? Go ahead, Dave, if you can answer it.

MR. SCHARF: (Inaudible), but there -- there -- I don't want to -- go ahead.

MS. GAYNOR: Yeah, so part of the thing -- and part of the thing with the Statute is that there's a statewide system designated to be manned by the Clerk, which they're still working on, as she stated. However, in the interim, the County is also in the process, and pretty far in the process of procuring a sole source software -- software system where we can track it.

And we'll be doing some manual tracking, but we'll only be able to have the local data. So it will be tracked in a software system that the County is purchasing. It's a case management software, but it allows us to track and do the other case management type things. And with that software, one of the things that we requested from the vendor is basically an ATI (Phonetic.) I'm not a technical person, but it allows law enforcement to search and to see that a person had a citation previously, and if it was successful or not.

MR. SCHARF: -- I haven't seen Alan for a while, but I do appear before that Workshop, and they've expressed an interest in it as being part of this. So if you want me to do it, I can do it, or --

MR. JEFFERSON: No. If that's the will of this board I --

MR. SCHARF: Well, you know --

MR. JEFFERSON: -- I'll go ahead and do it. That's -- that's not an issue. I can reach out to them.
