

BROADVIEW PARK SEPTIC TO SEWER CONVERSION

Septic tank systems are no longer allowed. Properties that abut a sanitary sewer line are no longer able to maintain, repair or install septic tanks or other similar sewage disposal systems. Provided below is the ordinance that prohibits septic tanks. Written notice of anticipated completion date and the availability of a new sanitary collection and sewage treatment and disposal utility system was furnished to the owners of all property abutting the new system. Failure to connect to the system may result in a notice of violation and fines.

As required by **Broward County Code of Ordinances Chapter 34, Article, Sec. 34-35. - Connection to public water and/or sewage in abutting streets and easements required -** "All premises used or intended for human habitation or occupancy, including, but not limited to, establishments to be used for household, domestic, food processing, food handling, restaurant, dairy or bottling processors, public buildings and places of assembly or other establishments within an area served by a public or private sanitary sewage treatment and disposal utility system, or where such system is available, and which abuts a sanitary sewer main owned by such system and is within the service area of that system, shall be connected to the said sanitary sewer main within one hundred eighty (180) days of the availability of said sewer main for use."

Funding Availability. Good news. Broward County has grant funding to help Broadview Park homeowners connect to the County's sewer system. Homeowners still using a septic system may be eligible for a program that offsets some of the connection costs. Broward County will contract to install the sewer connection for **homeowners who opt into this program.** Please note, funding is limited, and property owners must sign up by May 31, 2024.

Staff will answer questions about how residents can get their homes connected to the sanitary sewer system.

Back-to-School Sales Tax Holiday - July 29 - August 11, 2024

Qualified Back-to-School Sales Tax Holiday purchases include clothing, footwear and backpacks costing \$100 or less, school supplies costing \$50 or less, learning aids costing \$30 or less, and personal computers or computer-related accessories, including non-recreational software, costing \$1,500 or less.

Disaster Preparedness Sales Tax Holiday - June 1 - 14, 2024 and August 24 - September 6, 2024.

Qualified Disaster Preparedness Sales Tax Holiday purchases include supplies such as flashlights and lanterns costing \$40 or less; reusable ice costing \$20 or less; radios costing \$50 or less; tarps and ground anchors or tie-down kits costing \$100 or less; coolers and portable power banks costing \$60 or less; batteries and fuel tanks costing \$50 or less; smoke detectors, fire extinguishers, and carbon monoxide detectors costing \$70 or less; and generators costing \$3,000 or less. Other items related to the safe evacuation of household pets are also included.





Freedom Month: A Month-Long Sales Tax Holiday on Recreational Items - July 1 - July 31, 2024.

Purchases for admissions to music, sporting, and cultural events; tickets to movies and museums; single admission or season tickets to theatre and dance performances; state park admission and annual passes; and use of fitness facilities will be tax freetax-free. Tickets, memberships and passes, purchased can be used any time from July 1 to December 31, 2024. The month-long summer sales tax holiday also applies to sales of certain boating and water activity equipment and supplies, camping equipment and supplies, fishing

equipment and supplies, electric scooters, general outdoor supplies (including sunglasses, sunscreen, and grills), and residential pool chemicals, supplies and parts.
