BROWARD HEART PROJECT OFFERS FREE CARDIAC TESTS

The Broward County Board of County Commissioners funded a \$10 million pilot project to offer free preventive cardiac tests to qualified Broward County residents at local hospitals. The Broward Heart Project runs through 2024 and is available to qualified Broward County residents who have a family history of heart disease, or who struggle with high blood pressure, high cholesterol and/or other factors that may put them at risk of heart disease. BMSD BUILDING PERMITS STREAMLINED



Thinking of doing some home improvement projects in 2024? Broward County has some good news for residents of the Broward Municipal Service District (BMSD), because the process for receiving a building permit just got easier and faster!

Certain projects will no longer require a Broward County Development & Environmental Review (DER) prior to submission to the Broward County Building Code Division. This significant change is a cost-saving measure that will reduce the time needed to obtain a building permit for residents within the BMSD.

Projects that no longer require DER review:

- Driveways
- Fences and walls (residential)
- Generators, A/C units, and associated slabs
- Landscaping and irrigation
- Lighting, poles, (residential/commercial)
- Sheds (residential)

- Parking and striping (residential)
- Rooftop Solar panels
- Sheds (residential)
- Signs stand-alone or on a building (commercial)
- Shutters (residential/commercial)
- Windows and doors (residential/commercial)


All you need to do is submit your permit application to the Building Code Division at 2307 West Broward Boulevard, Suite 300 in Fort Lauderdale. We will take care of the rest.

DER may be required for projects with unique site conditions. County staff will notify the applicant if such a review is required. Please call the Urban Planning Division at 954-357-6666, ext. 2, if you have any questions.

MOBILITY ADVANCEMENT PROGRAM (MAP) IN THE BMSD

The Broward County Mobility Advancement Program (MAP Broward) is rolling into Year five of projects brought to you by the Penny for Transportation Surtax. Transformational projects will be coming to the unincorporated area soon.

The Broadview Park Roadway Drainage Project (Broward County Public Works): This mitigation project is designed to resolve significant flooding issues to ensure community resilience. The project also includes a comprehensive green infrastructure stormwater system to reduce roadway flooding. The County's Public Works team will be installing permeable asphalt for the roadway and permeable sidewalks. The project's elements are intended to reduce stormwater run-off causing pollution and address aguifer recharge: water guality and



capacity. This project received significant state discretionary grant leverage and is anticipated to be completed in 2028. For additional information, please go to the County's <u>website</u>.

2023 PROPERTY TAX BILLS ARE DUE APRIL 1, 2024

All 2023 property tax bills must be paid by the deadline to avoid delinquency interest, fees and penalties. However, a 1% property tax discount is available for all tax bills paid in full in February.


