



## Members of the Public:

To promote social distancing and avoid risk of additional community spread of the Coronavirus (COVID-19), the June 4<sup>th</sup> meeting of the Independent Transportation Surtax Oversight Board will have limited access for physical attendance by Oversight Board members, municipalities with capital projects and rehabilitation and maintenance projects in Cycle 1, Broward MPO staff, and required County employees. Limited seating will be available to maintain social distancing guidelines.

Members of the community who wish to speak on a mobility-related topic not on the Agenda (Agenda Item #1), a County project (Agenda Item #3), a municipal capital project (Agenda Item #4), or a municipal rehabilitation and maintenance project (Agenda Item #5) must utilize the remote public participation option.

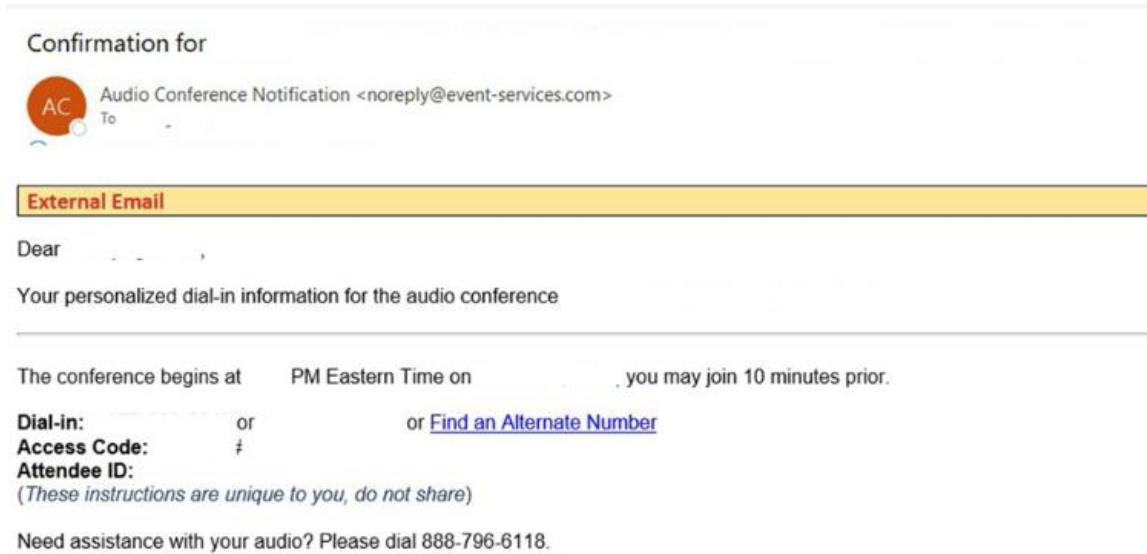

## On the day of the meeting:

- Call the telephone number you are given and enter your personalized access code. Your call will be answered, and you will be put into a "Listen Only" mode until the Item # is up for discussion.
- When it is time for you to speak, the Chair will direct the conference operator to unmute your line. The Chair will ask you to introduce yourself. You will have 2 minutes to speak. Groups of individuals wishing to speak on the same topic may be requested by the Chair to limit their remarks to 1 minute each.
- If you are going to watch the webcast/broadcast from a remote location, please mute the speaker on the device you are watching from BEFORE your line is unmuted to speak. This will help prevent feedback on the webcast/broadcast.
