

32% of County residents are foreign born; predominantly from Latin America; and more than 321,400 foreign-born naturalized citizens live in Broward.

MIGRATION

The high rate of international migration into South Florida has had a significant impact on demographic changes in Broward County over the past 35 years. In 2014, 32% of residents are foreign born compared to only 11% in 1980. The number of foreign born residents increased 400% from 113,339 to 577,843 in 24 years.







As the County transitions from a retirement destination, the number of families with children has increased. This is reflected in the increase in Florida natives from 20% to 33% between 1980 and 2014, while retirement age residents (65 and over) decreased from 22% to representing less than 15% of the total population. Also, persons born in other States outside of Florida decreased from 69% to 35% in the same time frame.


FOREIGN BORN RESIDENTS: 1980-2014

In addition to the increase in immigration to the county, the origin of immigrant residents has also changed over time. In 1980, the majority of foreign born residents came from Europe (including the former USSR). By 1990 European foreign born residents decreased to 28% and Latin American foreign born residents more than doubled to 52% in the same time period. In 2014, 79% of foreign born residents are Latin American.

ANCESTRY AND ETHNICITY

Since 2000, Broward County population has changed due increases in migration from Latin America and West Indian countries. Between 2000 and 2014, the West Indian population has increased by nearly 60% and the population with South American ancestry has increased by nearly 168%. The latter has influenced the increase in residents with Hispanic ethnicity in the County.

CITIZENSHIP

Increased diversity is also reflected in the substantial growth among non-U.S. citizens, as well as foreign born citizens (*naturalized*). The number of non-U.S. citizens in Broward County grew from representing less than 4% of the population in 1980 to over 14% in 2014 estimates. Significantly, the number of naturalized citizen also exhibited considerable growth, from 7.5% in 1980 to 17.7% in the 2014. This represents an increase of almost 250,000 new citizens for a total of 321,413.
