Dear Zoning Code Compliance Section Customer:

All CCS lien searches are required to be in writing and a fee received to have accurate records regarding the request and information subsequently returned to the requestor. The Broward County Zoning Code Compliance Section has jurisdiction ONLY in the Unincorporated areas of Broward County. If the parcel is located within a City you will need to request a search with that city.

Please be aware that some areas of the county have been annexed into cities and they were previously in the unincorporated sections. You can determine if a parcel was previously in the unincorporated area by searching the GIS **Annexation History** map at:

Zoning CCS searches include ONLY: Land Clearance Violations & Liens (previously Special Assessment Liens), Zoning Violations & Liens, Junk Property Violations & Liens; Zoning Citations & Liens. (**NOT Building/Permitting**). Attached is the Lien Search Request form for Zoning Code Compliance Section.

Search fees are listed on the search form: 2 - 3 business day return by e-mail or fax = \$60
7 - 10 business day return by e-mail or fax = \$30
