Public Hearing on Amendment to the Broward County Land Use Plan – City of Sunrise

Ms. Boy gave a brief overview of the proposed amendment and stated that Planning Council staff recommends denial of the proposed amendment, as it is not consistent with BrowardNext – Broward County Land Use Plan (BCLUP) Policy 2.14.9 regarding significant or adverse impacts to the regional roadway network.

Mr. Dennis Mele gave a brief overview of the project and asked that Planning Council defer this item until the October 27 meeting or until the transportation impacts are mitigated.

Commissioner Rich expressed appreciation for the affordable housing portion of the project. Secretary Gomez mentioned nearby roadway improvements and ensuring that the applicant is coordinating with the Broward MPO. Mayor Hardin asked for clarification on the affordable housing percentages.

Following the Chair's request for a motion, a motion was made by Commissioner Rich and seconded by Secretary Gomez to defer Item PH 7 to the October 27, 2022, Planning Council meeting or until the transportation impacts are mitigated. The motion was unanimously approved.
