To promote social distancing and avoid risk of additional community spread of the Coronavirus (COVID-19), members of the public and the media were encouraged to attend telephonically or view the live meeting via webcast; however, the Public Hearing was open to physical attendance.

CALL TO ORDER

The Chair called the meeting to order at 10:00 a.m.

Jo Sesodia, Director, Broward County Planning and Development Management Division, gave a brief overview of the proposed revisions. There being no discussion, the Chair requested a motion, a motion was made by Mayor Gomez and seconded by Vice Mayor Williams to find the revisions consistent with the strategies and policies of the BrowardNext – Broward County Land Use Plan and transmit the same to the Broward County Board of County Commissioners. The motion was unanimously approved.

R 3 EXECUTIVE DIRECTOR'S REPORT

Ms. Boy:

- Thanked the staff and Council for their support during the past four (4) weeks;
- Suggested that the Council cancel its September meeting, as no items were scheduled; the Council cancelled the September meeting without objection;
- Stated that December 2, 2021, was the preferred date for the combined meeting; the Council agreed to that date without objection;
- Stated that tomorrow (August 27) was Commissioner Parness's birthday and the Council wished him a happy birthday; and
- Stated that Sharon Walker of Planning Council staff was transferring to Port Everglades for a promotional opportunity.

PUBLIC HEARING AGENDA

Ms. Boy advised the Council that there were no public speakers signed in for Items PH 1, PH 2, PH 3 and PH 5 with the exception of applicants and one (1) member of the public signed in to speak regarding Item PH 4. Ms. Boy proceeded to give an overview of each item, including the Planning Council staff's recommendations.

During the overview of Item PH 5, Commissioner Rich asked a question about affordable housing and the applicable policies; the Council engaged in an extensive discussion regarding the applicant's affordable housing commitment, as well as its commitment to address Priority Planning Areas for Sea Level Rise prior to the second Planning Council public hearing. Dr. Jennifer Jurado, Broward County Climate Resilience Officer, provided additional information and input to the Council regarding the County's request for a legally enforceable mechanism as well as the Policy itself. The Council continued its discussion and Ms. Boy noted correspondence submitted by Benjamin Fessler and confirmed that it would be provided to the City and made part of the amendment report.

Following the Chair's request for a motion, a motion was made by Secretary Castillo and seconded by Mayor Gomez to approve items PH 1, PH 3 and PH 5 per Planning Council staff recommendations, including the 'conditional recertification' for Item PH 1, not requiring a second Planning Council public hearing and the 'conditional recertification' for Item PH 3 and addressing the Priority Planning Areas for Sea Level Rise prior to a second Planning Council public hearing its affordable housing commitment for Item PH 5. The motion was unanimously approved.

The Council engaged in an extensive discussion regarding the proposed amendment, including opposition due to the location on the barrier island. It was noted that the amendment did not propose any new residential units and the purpose is to denote an underlying "Residential" use as the building existed and predated the adoption of the 1977 Broward County Land Use Plan.

At the conclusion of the discussion, a motion was made by Secretary Castillo and seconded by Mayor Gomez to approve the amendment per Planning Council staff recommendation, including not requiring a second Planning Council public hearing and the 'conditional recertification.' The Chair called for a vote and the motion was approved. (Vote of the Board; 13-3; Yes: Breslau, Brunson, Castillo, Fernandez, Gomez, Good, Hardin, Maxey, Parness, Romaner, Rosenof, Williams and DiGiorgio. No: Blackwelder, Grosso and Rich.)

Ms. Boy provided a brief overview of the proposed land use plan amendment including highlighting the affordable housing commitment.

There being no further discussion by the Planning Council members, a motion was made by Secretary Castillo and seconded by Mayor Gomez to approve the amendment per Planning Council staff recommendation, including recognizing the affordable housing commitment, not requiring a second Planning Council public hearing and the 'conditional recertification.' The motion was unanimously approved.
